AMENDMENT #1 TO AGREEMENT

PARTIES

This first Amendment to Agreement ("Amendment") is entered into between Solano Community College District ("District") and **A2R Architects** ("Consultant"), collectively the "Parties").

RECITALS

WHEREAS, District and Consultant entered into a Consulting Services Agreement ("Agreement"), dated October 4, 2017, for architectural services related to the **Room 604 Renovation Project**

WHEREAS, District and Consultant desire to amend the Agreement to revise insurance endorsement requirements

NOW THEREFORE, in consideration of the mutual promises and covenants set forth above and contained herein, District and Consultant agree as follows:

AGREEMENT

- 1. Section 13.2.3 of the Agreement is amended to read in its entirety:
 An endorsement stating that the District and its Governing Board, agents,
 representatives, employees, trustees, and officers are named additional insured under
 all policies except Workers' Compensation Insurance, Professional Liability, and
 Employers' Liability Insurance. An endorsement shall also state that Consultant's
 insurance policies shall be primary to any insurance or self-insurance maintained by
 District. An endorsement shall also state that there shall be a waiver of any
 subrogation.
- 2. Except as set forth in this Amendment, all provisions of the Agreement and any previous extension(s) and/or amendment(s) thereto shall remain unchanged, in full force and effect, and are reaffirmed. This Amendment shall control over any inconsistencies between it and the Agreement and/or any previous extension(s) and/or amendment(s).
- 3. Consultant acknowledges and agrees that this Amendment shall not be binding on the Parties until and unless the Solano Community College District's Governing Board approves this Amendment.
