

**NOTICE OF PUBLIC HEARING  
ON SOLANO COMMUNITY COLLEGE DISTRICT  
ENTERING INTO AN ENERGY SERVICES CONTRACT**

**NOTICE IS HEREBY GIVEN** of the intention of the Board of Trustees of the Solano Community College District ("District") to consider entering into an energy services contract ("Agreement") with a vendor to design, install, and operate solar photovoltaic systems, battery electric storage systems, and electric vehicle charging stations on the District's Fairfield Campus, pursuant to the terms of Government Code section 4217.12.

The time for the public hearing on the intention of the Board to consider entering into the Agreement is **May 18, 2022 at 6:30 p.m.**, or as soon thereafter as practicable, at the Administration Building, Denis Honeychurch Board Room 626, 4000 Suisan Valley Road, Fairfield, CA 94534. As a consequence of the local emergency, and pursuant to AB 361, the Board of Trustees found that the District shall conduct their Board meetings without compliance with paragraph (3) of subdivision (b) of Government Code section 54953, as authorized by subdivision (e) of section 54953, and in compliance with the requirements to provide the public with access to the meetings as prescribed in paragraph (2) of subdivision (e) of section 54953. In the event of several Public Comment requests, the Board reserves the right to lower the allotted time to 2 minutes.

Those that submit an email will have their Public Comment read during the meeting so that it is part of the meeting record. Public Comments submitted in advance to be read during the meeting will also be limited to 3 minutes. In the event of several Public Comment requests, the Board reserves the right to lower the allotted time to 2 minutes.

At such time the testimony of all interested persons for or against the proposed Agreement will be heard. Any protest pertaining to the regularity or sufficiency of the proceedings shall be in writing and shall clearly set forth the irregularities and defects to which the objection is made.

Any written protest shall be filed with the Governing Board via [board.agenda@solano.edu](mailto:board.agenda@solano.edu), on or before the time set for the hearing. The District may waive any irregularities in the form or content of any written notice and at the hearing may correct minor defects in the proceedings. Written protests may be withdrawn, in writing, at any time before the conclusion of the hearing.
