The work under this contract will be in 2 phases. First phase (Buildings 800 & 1500) will be performed during Winter break of 2014 and second phase (Buildings 100, 500, 700, 1400, 1600 & 1700) will be performed during Summer of 2015 which includes, but not limited to, the removal of existing HVAC unit at Building 1600, Dry Wall, TSI/Duct Seam Tape, Lead, Gypsum Board Ceiling, and 2'x4' false ceiling panels. Demolition, removal, and disposal of all asbestos containing materials detailed in the Asbestos Abatement Specifications for Solano Community College, and as indicated on HMS front end documents, HMS and Kleinfelder reports. All work to be performed is under a single prime contract.

To bid on this project, the bidder is required to possess one or more of the following State of California Contractor Licenses: B, C-21, with ASB (Asbestos Certification) and HAZ (Hazardous Substance Removal Certification). The bidder's license(s) must remain active and in good standing throughout the term of the contract.
