## ITEM NO. 1 – ANSWERS TO SUBMITTED QUESTIONS

**QUESTION** – Is this RFP for design only, or a design/build?

**ANSWER** – The scope of work for this project is to provide a comprehensive assessment of the condition of the existing security camera system on all three District campuses and provide recommendations to the District, based on their goals. Selected consultant will not be designing a new system. Please review the request for 'Statement of Qualifications and Proposal' for scope of work and what is expected from selected consultant.

**QUESTION** – Will the College provide plot, electrical and signal plans for all three sites in AutoCad format?

**ANSWER** – Plot Plans are available in CAD format for all three campuses and will be made available to successful consultant. If available in CAD format, the District will also provide electrical and signal plans.

**QUESTION** - The SOQP suggests a licensed Engineer is expected to perform the work. Will this be a requirement for the project or will other industry certifications, experience and references be adequate?

**ANSWER** – A licensed engineer is desirable, however, other qualifications and experience will be evaluated and considered.

**QUESTION** - Will the access control system be included in the assessment project? **ANSWER** – No. Assessment and recommendations will only be for the exterior security camera system, including, but not limited to servers, storage, monitors and cameras.

**QUESTION** - Will selection as the company to perform the assessment preclude them from bidding on related future security projects?

**ANSWER** – The company selected to perform the assessment will be eligible for consideration to perform development of design and specification for potential future security camera system projects. However, the company selected to perform the assessment will not be eligible to bid on any future security camera system equipment and installation work.

**QUESTION** – Do you have an engineering estimate for the cost of this project? **ANSWER** – No, an engineer's estimate is not available at this time.

**QUESTION** – Are security system integrators and video surveillance system manufacturers allowed to submit a proposal for this project? **ANSWER** – No. The District is looking for firms that are not affiliated with any equipment manufacturer or vendor, nor have a financial interest in any equipment manufacturer or vendor companies.

**QUESTION** – Will only CA licensed engineers/designers be allowed to propose on this project?

**ANSWER** – No. A CA licensed engineer/designer is desirable, however, other qualifications and experience will be evaluated and considered.
