### Discussion/Information Items:

- Membership still need a CTE, Math/Science, Counseling, Social and Behavioral Sciences representative
- 2. Status of programs under review/accreditation (see attached handout). Leslie Minor completed the program reviews that she had on her desk. Robert Gabriel asked for feedback on whether EMT (Emergency Medical Technician) should be reviewed separately in the next round. The committee said yes since they are not governed by the BRN review. Even if there isn't a degree, the analysis can help understand student success rates, scheduling, resource needs, etc.
- 3. Yearly program review follow-up CurriCUNET page. Ferdinanda and Amy shared their drafts of a yearly program review follow-up form. It would mainly consist of program goals and any updates/changes to those goals. They shared their idea of having the form on CurriCUNET rather than a hard-copy. This would be easy to update and access by faculty, deans, and administrators and could more easily link to institutional planning. For example, if there was a goal of a faculty hire, a box could be checked that would alert administration of the request. They also suggested changing the way the goals are written. Rather than short or long term, separate goals into categories that align with the program review self-study rubric.

- The committee seemed in favor of this idea and suggested using time at the next meeting to brainstorm what the CurriCUNET page might look like.
- 4. Update on evaluation of program review committee. Once all the feedback has been collected the committee will discuss the findings and begin to make recommendations for changes to the process and template

  - b. Committee members feedback, deadline September 12, 2016
  - c. Stakeholders, deadline September 19, 2016
  - d. Dean's feedback, complete
  - e. Superintendent President/Vice President of Academic Affairs, will come to our next meeting on September 26, 2016
- 5. A team of faculty members met to review the General Science Program Review selfstudy. Feedback will be compiled by the Academic Program Review Coordinator and shared with the discipline faculty.
- 6. The math program review will be discussed by a team of faculty reviewers on Monday, September 19<sup>th</sup>.
