Math AB705 Update -

Senator Randy Robertson provided an update (from Sarah Donovan) on Solano's activities with AB705. Curriculum changes and assessment methods are aligning our college with the legislative mandate. The Senate would like to recognize Sarah Donovan for her leadership and the math faculty for their efforts.

Canvas Data & OEI Exchange Survey for Faculty – Erica Beam

The OEI goal is that by 2022, all 114 colleges be on the exchange, but so far, Solano has not entered.
