# **TEN PLUS ONE**

A student survey about NetTutor usage went out this fall. 744 entries were submitted. 89.5% of respondents have not used NetTutor (most indicating that they didn't realize it was free and available). Many indicated that now they know it exists, they might use it, and – in fact – after the survey went out, NetTutor usage numbers have risen. For students that used the service for non-math support, 89% were satisfied. Discussion ensued regarding a question about the quality of NetTutor services in comparison to inperson tutoring.
