PUBLIC COMMENTS

A/S PRESIDENT'S UPDATE

Hayward Award Winner: Tony Zitko, part-time political science faculty, is the Area B 2021 winner of this award. Senate offers congratulations to Tony who is currently serving as the Interim Associate Dean of External Programs.

Academic Senate Elections: are in the works.

Guided Pathways Coordinator/FYE Update: a small group met to discuss restarting GP and institutionalizing this equity work. The committee's chair (cochair) leadership and job descriptions are being discussed along with the need for administrative support, ties to ASTC, and more. GP is now under VP Cooper.

SESC & PD/Flex Cal coordinator positions update: both positions were announced/posted this morning by HR. Interview committee members are needed.

ASSC Outcome Update: per a meeting with ASSC re: the recent joint Flex session, Senate has agreed to dedicate more professional development towards the outcomes the ASSC identified. A student led panel on these outcomes is planned for our upcoming 3/17 flex. Students want more interaction with each other and with faculty.

BOT Report: shared the outcomes and discussion above (ASSC meeting) plus noted that Andrew McGee was nominated for the Stanback-Stroud award.

INFORMATION/DISCUSSION

VP Diamond SCC Budget Update

Shared SCC student success metrics compared to state averages – and the funding formula in relationship to the budget. We are below the state average in most metrics; our funding will be reduced if we don't improve our numbers. Things we can do: encourage students to finalize their graduation petition before the end of the year, encourage certificates and degrees, look at curriculum design and how it affects the success metrics, etc. The current year and next year look good, but we need to improve numbers by the third year.

Textbooks - David Williams, LaNae Jaimez & Atticus Frey

Textbook access is an equity issue. VP Williams would like Senate to think about developing a statement on textbooks and provide guidance/resources to faculty who wish to move towards ZTC (Zero Textbook Cost) or Low-Cost textbooks.

Atticus Frey reported that there are some districts that offer incentives to faculty for shifting to OER and discussed copyright law (as it pertains to putting your textbook in your shell), reimagining what OER means, the evolution of a particular OER source after it's been augmented by previous users, and more.

This discussion will continue at the SESC meeting on Friday 2/25, if anyone would like to attend.
