Campus Housing & SB169: These funds are limited by legislation to be used for “traditional student housing” (FT, 12 units, no dependents). While this doesn’t serve our entire student population, we will apply (phase 1) and then pursue funding for phase 2 (students not covered by Phase 1) and phase 3 (active seniors etc.)

Housing and SB169 funds: These funds are limited by legislation to be used for “traditional student housing” (FT, 12 units, no dependents). We will submit our application for funds in early July; funds are expected to disperse in 2024 and construction would take place in 2026-2027. Space for building may be the green between the soccer pitch and softball field.

Senate voted to move forward with taskforce's plan.
