Self-Assessment

- To what degree has the committee met its roles and responsibilities?

The DE Committee has performed its roles and responsibilities with effectiveness and professionalism. We completed all course shell reviews consistently, rigorously and on deadline. A variety of other initiatives were developed and implemented (see above).

- How can the committee improve its effectiveness in meeting these roles and responsibilities?

The College needs to develop a process of supporting faculty in their committee work so that they can spend more productive time on committee tasks, including doing committee work between meetings. As it is, faculty are overwhelmed by a myriad of

other tasks (PLOs, SLOs, Program Review, etc., etc.). Some committee members do committee tasks on their own time; others are not as productive. Thus, under the current system, the most conscientious committee members are the most overburdened with work. This is a path to burnout.

- How effective was the committee in completing its initiatives?

The DE Committee developed a clear agenda at the beginning of the academic year and made significant progress in meeting its goals & objectives. (Details above.)

- How might the committee improve its effectiveness in regard to completing initiatives?

Improve coordination with the Administration and other committees, such as the Flex Committee, to more effectively plan for faculty training and professional development.

- How effective was the committee in impacting student success?

We developed a “First Three Days” program to start each semester with the maximum amount of student participation. Inactive students were dropped after three days so that waitlist students could gain access to online courses.

We worked throughout the year on a mandatory student orientation program that will be activated in 2017. This program will help to insure that our students are prepared for online learning and receive the support that they need to succeed in online classes.

- How might the committee improve its effectiveness in regard to impacting student success?

Implement the Mandatory Student Orientation Program. Collect data on student success rates and adjust online teaching practice accordingly.

- What resources are needed to assist the committee in meeting its initiatives?

The College must honor the intent of the Online Education Initiative (OEI) and use the funds made available through this program to enhance the Distance Education program and improve student success in our online classes.

The Distance Education Budget (created from funds made available through the OEI program) should be fully implemented.

Specifically, we must proceed with the creation of an Instructional Designer position (or an equivalent position) to assist faculty in developing more effective teaching strategies for online classes.

Recommendations

- Provide recommendations for changing the description or composition of the committee to achieve its initiatives addressed for next year.

It would be beneficial if the DE Coordinator and the DE Committee chair were two different people. This would create a more balanced and diverse DE leadership team.

- What topics should be addressed by the committee next year?
 - Full implementation of DE Budget
 - Implementation of Mandatory Student Online Orientation
 - More robust student support for online classes (i.e., online tutoring, live, real-time communication, online counseling).
 - Preparation for OEI Course Exchange.

- Are there additional roles or responsibilities this committee should be addressing?

The committee could become a focal point for the promotion of teaching innovations in both online and face-to-face classes. We would need an Instructional Designer to take on these tasks.

- What issues, initiatives, or work has the committee identified that other committees, service areas, and/or disciplines or Schools should address next year?

Support for faculty in developing innovating teaching – Flex Committee, in conjunction with Academic Senate.
