#### **ACADEMIC SENATE PRESIDENT REPORT**

Introductions were made with/to the new Senate Administrative Assistant, Sheila Kaushal; her presence in this position is greatly appreciated.

The campus is in great need for an incoming Curriculum Committee Chairperson for Fall 2017; training and support opportunities are available this Spring and Summer, so finding someone to fill this critical position now is important.

Changes to the way courses are approved are coming; many courses will no longer require Chancellor's Office approval, which gives our campus greater flexibility to respond to student/program needs, but also means the local approval process needs to be meticulous and robust.

The new Articulation Officer will be Curtiss Brown, outgoing Curriculum Committee Chair. The new Program Review Coordinator is Ferdinanda Florence. The DE Coordinator position will be advertised soon, with 30% release time.

Curriculum, Hiring, and Assessment handbook revisions are underway.

CurricUNET Meta is slated for use/action by the end of January. Hiring for eight new faculty members is planned, while aiming for 10 total, funding permitting.

The new Dean of Student Services is Shannon Beckham, and the new Dean of Academic and Student Success Dwayne Hunt.

David Williams is serving as a curriculum consultant to shepherd key projects so as not to lose momentum until we hire a new VPAA. The search for a new VPAA is in effect, with a goal of filling that position in early April.

Our enrollment numbers are down; please employ a "Take One More" attitude in adding students to your classes. Recent outreach efforts (billboards, Facebook, Spanish/ESL outreach) and six enrollment generalist positions (to allow for an SCC presence in the high schools) have been employed.

#### **ACADEMIC SENATE PRESIDENT REPORT**

A steering committee for the California Pathways Grant (see previous Hot Topics) is being formed; Dean Morinec will present items for this grant requiring senate approval at the next two Senate meetings.

Spring 2017 Plenary: will be held in San Jose; three senate representatives will be attending.

Elections for School representatives are to have taken place by March 15, 2017. Senate Exec will conduct a concurrent election for at-large positions as well as for the ratification of revisions to Senate by-laws. Updates to the Senate Constitution and By-laws will be need to be ratified this semester.

The college is evaluating how it might continue providing F2F courses at the prison. We are the only college doing F2F instruction in a prison. We need more SCC faculty to teach courses there to reach the Prison's goal of offering more than general education classes, so that those students can complete a certificate program.

#### **BUDGET UPDATE, VP LIGIOSO**

The 2017-18 state budget reveals growth reductions.

Several one-time funds are coming for educational services, technology, enrollment growth, facilities and equipment, etc. Prop 99 funds are coming. The new library building was not on the list of approved projects. Senate agrees to revisit the needs of the library with the S/P and our Board at our next meeting. VP Ligioso presented on the 2017-2018 proposed budget for CA CC's, located here.

Senate President Wyly reiterated several reasons why faculty presence at Graduation is desired (an institutional history where faculty involvement was downplayed, Distinguished Faculty awards are presented, our students like to see us there, etc.)

#### SUSTAINABILITY ADVISORY COMMITTEE

The Committee reported on their current projects, recent successes, and future plans. The desire for a "green campus" is also being affected by state regulations.

#### PROGRAM REVIEW

A "program review update" form (Self Study Template) was presented to the Senate and approved unanimously.

#### **ACCREDITATION UPDATE**

Senators and reveiwers have access to 9 of the 13 standards. 2C (Student Services), 3D (Fiscal), 1C (Institutional Integrity), 3C (Technology) still need work to become review-able. The next Senate meeting will be devoted to this topic.

#### **BASIC SKILLS COMMITTEE**

The most recent meeting (4/28) was CTE-focused. The next meeting (5/12) will focus on the basic skills committee's mission and purpose.

#### HIRING MANUAL

The Equivalency Determination Procedure and its screening committee was discussed. Additionally, "diversity" of the hiring pool is defined, per state and federal regulations, to include gender and ethnicity. Senate concerns still exist about ensuring a hiring pool that represents the
