- 1. Call to order Joshua Scott, Chair
- 2. Comments from the public.

Josh reported that he, Sarah and Heather presented at the ASSC Conference & their work was well received. They presented the data of our successful English Co-req offering, and Heather presented accompanying pedagogy.

Isabel: Question about PD opportunities for TA's. State-level Puente is sponsoring Isabel's Puente TA to travel to the Spring Puente conference in Southern CA. Are there ways we can sponsor PD for TA's locally?

- i. Jose mentioned that Dwayne has approved funding for TInformation campaign (recruit faculty). Many of us don't know what is needed. There is a lot of misinformation out there. What programs are offered?
  - 1. FLEX!!!
  - 2. Shadowing system—let faculty visit facilities
- ii. Training for interested faculty
- iii. More cooperation from certain disciplines (staffing)
- iv. Work on math and English placement

- v. Re-Start program for formerly incarcerated students
- A's to participate in FlexCal when in pertains to their assignment, but it's on a case-by-case basis.
- Isabel: How about if they are accompanying students to a conference, as with Puente? The committee agreed this should always be covered, and suggest this to Dean Hunt.
- Several felt that TA's should also be sponsored to go to CAP conference, as it would be helpful for them to have more training in the philosophy and pedagogy.

- 4. **Discussion of our Prison Program.** We have invited several people involved in our prison program (including Shirley Lewis, Theresa Brunner, Andrew Wesley, Nick Turney, and Peter Zitko) to join us in a discussion of our current and future prison program. We'll cover the following:
  - b. A summary/explanation of what we've been doing
    - i. Dean Lewis presented an overview of the program's history and current status (attach PPT)
  - c. What's working, what do we think we're doing well?
    - i. Enthusiastic &intrinsically motivated students
    - ii. Students want more classes
    - iii. Committed, engaged faculty, staff & effective leadership
    - iv. Prison is interested in any classes with the potential to improve the cognitive behavior of the inmates
  - d. What's not working, what has frustrated those who have committed to this program?
    - i. Lack of resources: classrooms, library resources, etc.
      - 1. Most classrooms hold only 15 students
    - ii. Logistical / Institutional inconveniences
      - 1. Instructors don't always get advance notice when their classes can't be held for whatever reasons (lockdown, flu shots, training, etc.)
    - iii. Program would benefit from more autonomy in hiring, scheduling, class max, etc.
      - 1. Deans need to be willing to allow / enable hiring processes to hire new adjunct for this program if no current faculty are interested
    - iv. Lack of information to faculty: what disciplines are needed, what are the rewards and challenges, clarity that not all "prison programs" are alike.
      - 1. Professional development, tour, mentors, job shadowing could help dispel preconceptions and get more faculty interested.
  - e. What planned next steps are in the works?
    - i. Dept. of Correction has contacted Shirley re: potential to start a new cohort within the "DeLancey St." program
    - ii. English 1 / LR10 will be offered for the first time in Spring 2018

# iii. Math Placement

- Math was offered for the first time but placing students was a problem; had to use Accuplacer, and many students seemed misplaced
  - a. They don't have HS transcripts, but they aren't allowed in the program is they don't have diploma or GED; they should be able to self-report
  - b. Maybe offer Math 112? But, Shirley reports she can't get instructors for 112, even for Vallejo Center.
- f. Are there other solutions/next steps that we need to consider? How could the basic skills committee help in this effort?
  - i. We can make recommendations to Celia, who sits on an advisory Board working to improve prisoner ed. Programs.
  - ii. Information campaign (recruit faculty). Many of us don't know what is needed. There is a lot of misinformation out there. What programs are offered?
  - iii. FLEX activity in January.
