 - i. *To promote, plan, implement and assess the programs that advance teaching, student learning and institutional effectiveness to increase student success and completion while addressing identified equity gaps across the campus.*
 - ii. *To assist with the development and implementation of plans, teaching strategies, and resources, where appropriate, including the Student Success and Equity Integrated Plan, to increase student retention, success, and persistence, including how to address identified equity gaps.*
- d. This discussion also affords us the opportunity to clarify the role of the council as a sub-committee of the Faculty Senate with wider, inclusive membership and voting.

- a. We'd like to brainstorm ideas for hosting an SESC event during the upcoming FLEX day on October 13th. We should create a workgroup to carry forward the planning and report back to the council. We briefly touched on topics related to faculty and student support during these difficult times.

- a. We'd like feedback on the appropriate meeting structure for this year. For example, in order to accomplish some of the tasks and initiatives we wish to support, there will be a need to organize how the work will get done in between meetings. So, one proposal could include meeting as a large group once/week with intervening Fridays set aside for working groups to meet and progress projects.
