Discussion: At the Nov. 8th meeting counselors requested course numbers remain consistent and Teaching in a Diverse Society, numbered CDFS 054 was tabled to examine the possibility of retaining number 053. M: Erin Duane

Discussion: Amy Obegi reported that Nutrition 053 was created several years ago with the understanding that the Curriculum Alignment Project was coming forward, but there was confusion if the course could be taught by ECE as well. In the process of working with Robin to assure the revised Nutrition Course met CAP requirements, an identical class was created in the Child Development Department. The two classes are cross listed and can be taken in either department. CDFS 053 met CAP standards with modifications. Faculty and Robin agreed the number could be changed to CDFS 054 to match the Nutrition course number. This class could potentially be GE and Amy will pursue that with Robin towards a goal to create a transfer degree in Early Childhood Education (ECE).

Betsy asked why the objectives are the same in both courses, but the outcomes are not. Amy replied that SLOs can't be adjusted in course modifications and she submitted it to Tracy Schneider. Pei-Lin added that there is an SLO update process in CurricUNET and the SLO will be changed.

Discussion: Maire questioned the accuracy calling this a prerequisite rather than a co-requisite and how there can be lecture hours associated with it. Betsy responded that a co-requisite has to be taken concurrently and this lab can be taken independently, is self-contained and self-explanatory, and students can be successful even taking it sometime later. Because instructors spend time giving instructions and students have to turn in activities they do outside the lab, it warrants having lecture included. This is the only college she's been in that requires concurrent courses. While it might be optimal, requiring concurrent labs would take away student options, flexibility and freedom to take labs later and close the door to that opportunity. Maire countered that in her experience many university courses are required concurrently.

Pei-Lin noted that the course was modeled after BIO 12L with the lab portion added. Technically co-requisites can only be done one way and create registration problems. Robin added that many other courses in the same format would need to be changed along with this one. Maire pointed out that for a course to be a prerequisite, we have to demonstrate that a student would have to take the prerequisite in order to be successful. She added that sometimes students have too many options that become confusing. Betsy replied that the assumption is that you cover material in lecture before lab or sequentially. Joe clarified from reviewing the PCAH (Program and Course Approval Handbook) that if a course can be taken concurrently and as a prerequisite, it should be called a prerequisite. A corequisite can only be taken concurrently while a prerequisite offers the option. Joe read "It is possible that a course may be established as a prerequisite or co-requisite. In this event the student may enroll in the prerequisite or co-requisite course either prior to or simultaneously with the target course." So it can be both. Marianne queried if it could be changed to an advisory. Robin responded that advisories are not accepted by UCs and the numbers would have to be changed
