Dale explained that there has been correspondence, especially from UCs, regarding articulation. The History modifications address very specific changes they need to see. The timeline is urgent so that courses aren't taken off the list.

a. (CP12-116) HIST 002 World History to 1600

Student Performance Objectives, Assessments, Textbooks

1) Action on the course

Discussion: Dale reported that research paper assignments are optional because students cannot be required to write papers without an English pre-requisite. Dale and Committee members agreed it would be best to remove the word "research" from 11.4. Removal would not prevent research. Erin Farmer suggested adding "at the instructor's discretion an additional paper or essay on outside reading, 4-6 pages" would clarify that it would be an option for instructors and not students. Upon agreement, Joe amended the wording. Regarding Part 4, Dale explained that the general history content covers to 1600, but it is not uncommon in history to have some overlap, and mention of 1750 in the content outline does not need to be changed there, but only in the title. Joe pointed out that SLOs cannot be adjusted in modifications, so Dale added new SLOs under 10b – Student Performance Objectives. Joe or Erin Moore will move them to 10a later.

b. (CP12-117) HIST 003 Modern World History

Discussion: Dale reconstructed the content outline. Under 11.4 Joe amended it to read "at the instructor's discretion an additional paper or essay on outside reading, 4-6 pages" as discussed in 7a. There was a discussion about establishing an English prerequisite. Previously, prerequisites had to have statistical validation to be enacted. Statewide changes that went into effect last year allow content review as the basis for establishing a prerequisite, but some statistical analysis is still required. In order to implement that Board policy would have to be changed. Joe considered that, with data from Peter Cammish, a pilot group with an English 1 pre-requisite might eventually be possible. Board policy should be reviewed but this would be an item of future business. Joe has been watching for a policy template to cover that. The up-coming State Curriculum agenda will include pre-requisites, so he may have an update soon. Joe added it can be a Catch 22 because there would have to be a sufficient number of

sections offered which could diminish the pool of students, at least in the first semester, and schools need to offer adequate resources for pre-requisites.

Discussion: Under 11.4 Joe amended it to read "at the instructor's discretion an additional paper or essay on outside reading, 4-6 pages" as discussed in 7a. Joe reported an item came up in tech review under additional assessment information to change "in-person" to "in proctored setting" whether for online or face-to-face. Diane agreed and Joe changed it. Diane also listed example texts and other references there, because her impression from UC was that they want that based on preliminarily review and approval by someone from UC. Dale explained that Robin Arie-Donch took the modification to UC for their assessment and they said it was fine. Jeff opined that would not set a precedent but It is redundant. Dale added that UC sent sample outlines and that extra listing was appropriate. Jeff responded that they may not have other sections for textbooks or readings on their forms and it's unfortunate to get down to that minutia. Dale replied that UC history departments are getting that way and he reiterated that it may not be the same for other departments but this is what they approved for history. Joe added that different UCs may not agree with what is in a particular course. Dale reported that Robin has been working on what is satisfactory for the whole UC system. The common course outline for CSUs is an example of working towards consistency.

Discussion: Under 11.4 Joe amended it to read "at the instructor's discretion an additional paper or essay on outside reading, 4-6 pages" as discussed in 7a. The course outline changed in form and not content. Jeff noted the <u>Tragedy of Vietnam</u> textbook should be updated to the 2011 fourth edition. Maire queried if "lecture" means faculty have to spend three hours a week on each topic. Dale responded that there could be variety of activities and had decided it doesn't imply three hours a week. Maire asked if "lecture" could be taken out as a heading under Course Content. Agreement was to remove that heading. Joe pointed out that the Ed Code or Title 5 does not say that course content has to be in outline format. A: Passed as amended – Unanimous
