The only change made after discussion at the last meeting was removal of the duplicate Title 5 quote. The form would be used for courses instructors want to be repeatable. Under the new rules courses will not be repeatable unless they fall into one of the three categories for repeatability. Some courses will just need verification from the COR. If CSUs or UCs say a course has to be repeatable, Title 5 regulations require documentation that verifies that and the form would be used as part of that required documentation. Anyone could try to have a course repeatable. Joe confirmed that open entry/open exit variable unit courses can be taken until the unit maximum is achieved. The form will be found in My Solano Curriculum Committee resources link. Erin Moore suggested putting a note in the CurricUNET repeatability field "due to changes in Title 5, repeatability is subject to provisional approval." Joe pointed out that once the new rules are officially approved schools will have 180 days to implement. Joe will share this information at the next Academic Senate at meeting.

Discussion: MATH 112 was tabled after discussion at the last meeting to investigate if it could become a prerequisite for stats. The state is not willing to include it for transfer in the GE pattern. Robin checked into this and was told stats must have intermediate algebra as a pre-requisite under the current regulation. A state-wide discussion is in process and things may change. Genele Rhoads would still like to do this course modification whether or not it turns into a prerequisite because the course meets AA requirements for Intermediate Algebra or equivalent. The course content changes make it a better course, more contextual, and more applied than MATH 104.

Maire raised concern that the Curriculum Committee is approving workload changes as this course changes to 4 category hours from 3.1. Joe responded that the contract only addresses class max changes and unit values have been changed many times without changing the instructor's load. Genele added to the outline and level of difficulty and the Committee must decide if that is enough content to make unit changes. Maire also questioned the lab hours without a statement that "lab hours may be scheduled or TBA depending on the section. Joe pointed out that the statement "students are expected to complete that part of course" pertaining to lab scheduled as part of the class or TBA was approved last year, but hadn't got through the Chancellor's Office due to delays but Genele had to work with the old outline which needs to be merged with the earlier approved change. The Committee made the approval for all math classes that have lab so it needs to be put in this one. Marianne recommended it should state "requirement" rather than "expected". Joe replied it would be best not to change it now in order to be consistent and revisit it during curriculum review.

As Robin recommended under Section A, Joe changed "It will be modified and offered as an alternative prerequisite for Math 011 and Math 012" to "It may be offered in the future . . ."

Marianne noted the course description needs accuracy and requested it be on record for the Committee to come back to this course when she clarifies the issue. Robin pointed out it is geared to students who don't plan to transfer and to not mislead students it should say "class is not designed for students who plan to transfer". It could be amended if it becomes a prerequisite for stats.

Items 8p-8s, 8v, and 8w don't show up as UC transferable. The numbering got out of sequence because one of the courses was shut out of UC transfer. Robin expressed concern about losing transferability and recommended checking these course numbers.

Jeff noted course descriptions of 47A and 76B are almost identical. Marc is probably attempting to create parallels but has new ideas with a different vein. Families will need to show demonstrably different courses.

Discussion: Members questioned how prerequisites can be taken concurrently when co-requisites are the courses to be taken concurrently. Registration issues need to be considered with co-requisites. The prerequisite definition states the student has to enroll in the course prior to enrollment of target course. The co-requisite definition states the student may enroll prior to or simultaneously with the target course. Banner causes issues with courses set up as co-requisites. Banner only allows courses set up as co-requisites if taken at the same time as the target course. Marie noted that the Chancellor's Office regulations need to be followed and if Banner is the issue, then Barbara Fountain should be brought into the discussion. Erin Duane replied that Barbara is aware of the issue. Erin Moore stated that to simplify this, there needs to be a distinction. If enough schools have the same issue and contact the Banner Committee, they can write something to address this. Banner will do a variable unit at an extra cost. Many schools have made changes so they don't have an aggregation of students trying to add classes. Maire reiterated the course is either a pre-or a co-requisite and it doesn't make sense to make pre-requisite something that can be taken concurrently. Erin Moore recommended faculty be asked what they want to do. Erin Duane asked for consideration of what is in the best interest of the students. This issue comes up in sciences a lot. CINE 16 doesn't have that terminology.

Joe noted that this is what has been done in many courses and if this one course is changed, many other courses will need to be changed.

11. REPORT FROM THE CHAIR

a. New transfer degree rules

Up to this point, when the transfer model curriculum was prepared for a transfer degree and it had courses that matched a C-ID number they could be self-certified as equivalent to the C-ID by the submitter. That will no longer be allowed. For example, General Psychology PSY 110; this was developed by the CCC and CSU systems so CSUs know what they're getting, and faculty can have detailed course descriptions similar to Section K. Some instructors throughout the state abused the previous system which allowed them to testify their courses matched the C-ID descriptor but that is no longer adequate. For TMCs submitted after January 1, the schools course outline of record has to be approved through the C-ID approval process before it can be put on the form. The Articulation Officer has to submit to the network to be reviewed by CSU and CCCs review faculty and then will either be approved or sent back for changes. This is a major hoop now put in place.

Regarding TMCs that haven't been done (submitting AA-T or AS-T for TMCs), Joe reiterated that courses identified with C-ID identification have to be approved by the system and can no longer be self-identified. The state has not given an extension on time for TMC approvals, and 100% of programs that have TMCs need to be submitted for approval by June 2014. It is unknown what penalty there will be for any not submitted. The six TMCs that have been approved (through today) need to be investigated to ensure they match existing C-IDs. MATH 40's C-ID equivalent is MATH 21, so it will have to change to meet the C-ID descriptor. Also, the C-ID descriptor for stats was withdrawn and re-vetted, probably examining algebra as the pre-requisite. The transfer degrees need to be worked on and completed. Joe reported this information to the Senate last week and he will create a flow chart over break so faculty can begin preparing. There are currently 22 existing associate degrees for transfer available and Solano College has18, but the list will grow. Representatives need to inform their constituents. Joe will email a copy of the TMC chart, links to the TMC form, templates, and C-ID information and descriptors.

Maire was told by a nursing consultant in November that California will have high-unit and low-unit degrees and the Department of Education says it will limit degrees to 60 units. That means courses such as Nutrition, Growth and development would have to be dropped. Most of our nursing programs are high-end, around 70 units.
