11. REPORT FROM THE CHAIR

Joe reported Liberal Arts Curriculum Review is in process and Kinesiology people are hoping to complete their review begun last year. Joe attended the STEM conference in San Diego covering for the coordinator of math and as Curriculum Committee Chair. TMC/Transfer degrees for the STEM area were discussed. Joe learned that a computer science degree is not required for Solano, as was previously stated, because the College does not have what the state is looking for in a transfer degree. The TOP codes differ, the state requires more math and science than we have, and the College does not have a corresponding associate degree. Transfer degrees have to be submitted by fall 2014. Joe also heard that the C-ID process is not proceeding very smoothly and he stressed the importance to get C-ID approval items submitted as soon as possible.

12. REPORT FROM THE EXECUTIVE VICE PRESIDENT OF ACADEMIC & STUDENT AFFAIRS

Diane expressed concern about C-IDs not matching with UCs. Joe replied there has been discussion about having UCs on board but he has no information on progress. Due to the state mandate to have C-ID approvals prior to completion of transfer degrees, local courses and curriculum will have to be driven by the C-ID goal. These transfer degrees will be good for some students going to CSUs. Joe also noted that most schools will keep their old degrees to give students alternate paths for transfer.

Degrees with courses that have too many units won't work and will be called transfer model curriculum. Only 60 unit degrees will be accepted and students won't get financial aid for extra units. Maire reported that Nutrition and Lifespan Human Development courses will have to be dropped from the nursing degree to stay within the 60 units. Also lecture or lab times will have to be reduced here to be within the accepted units. There are hospitals in southern California that are accepting associate degree nurses and then require them to get their BSN. The costs for nursing students are a concern. If we don't have BSN courses students will go somewhere else. Joe pointed out an advantage for students is that CSUs have to guarantee availability of courses necessary for students to complete their transfer degrees with the 60 units.

a. Repeatability resolution

The resolution will be voted on at the next meeting. Lists of repeatable courses must be submitted to Joe so they can be placed on the resolution list. Many CTE courses related to industry retraining will not be repeatable and the students will have to petition individually to repeat a course, after a significant length of time, they need to meet industry standards. Joe will add a clause to address that. Faculty in occupational education, adaptive and other areas will have to inform students what can be taken again.
