Discussion: Michael Wyly began a presentation prepared by English faculty to explain justification for the proposed increase in units. Hardcopies of the presentation were distributed. He noted that extensive vetting in the English department resulted in the rationale for the decision. Michael, Erin Farmer, and Melissa Reeve, in turn, presented information on English SLO/PLO fall 2012 assessments; C-ID and curriculum-appropriate base-line standard for unit measurement; definition of "1000 words"; typically higher workload in English 001 than 002 and 004 due to student needs; argument is not for additional workload, but for what is already established; options are unit increase and/or differential load increase; student survey results; student benefits; growth to FTES and efficiency numbers.

Diane pointed out: the District's job is to ensure affordability; all points need to be carefully reviewed; Dean Vines and Dean Lamb have a list of interrogatories that were not addressed in the presentation; FTES numbers look correct but the fill rate is different and the score card will ultimately affect College funding; more FTE has to be measured against personnel cost; if unaffordable, sections would be cut back; more time is needed to address the issues; language was used in the presentation regarding workload, which is not under the Curriculum Committee purview; Article 19 (workload) is currently under negotiation; the bargaining agreement allows for adjustment in course categories and should not be done in this Committee; there will be a disparate impact in part-time and full-time breakout of loads that the department and district needs to take into consideration. Diane concluded there is more due diligence to be done. Joe requested the Committee consider a motion to table English 001, 002, and 004 until interrogatories, including bargaining consideration of faculty load, can be addressed. Diane pointed out that even though the presenters stated there is no request for increasing faculty workload, it was used as part of the argument raised. Issues related to unit values have a lot to do with faculty workload. With the request for four units in all three courses, there will be load implications as well as the disparity impact of full and part-time faculty. Those courses asking for adjustments that overlap into workload need to go to collective bargaining first and the Curriculum Committee should not be used or mis-used for that purpose.

Michael Wyly stated that, while there is a clear division between 10+1 and bargaining, this issue was based on student load and he asked not to lose sight of the work students are already asked to do. He added that the Committee's job is to regard curriculum as part of 10+1 and how it will impact other elements at the College can be taken to other venues. He encouraged everyone to regard arguments that are changes to 10+1. Students are now getting 3 units of credit for 4 units of work already done. Diane pointed out that the Committee looks at student work and bringing in load differential is another discussion; it would be disingenuous to include in the presentation without doing the homework.

Jeff noted that curriculum offerings and staffing and finance administrative issues intercept on this topic; faculty took the first step using due diligence regarding impact of student success from curriculum perspective; it is not appropriate to take action here without addressing the other components; making the change will require all parts to be synchronized and district level components must be considered for that decision to be implemented. Michael stated that the Committee should be able to vote on the changes and conversations regarding administrative concerns could be held separately. Faculty are asked to look at program assessment, reflect on SLOs, present concerns to the Committee, and he doesn't see a flow chart to address curriculum outside of the Committee and he expressed frustration that the many hours of work on this issue per methodology presented to them is not being honored. Joe responded that the Committee values the work but also needs to accept the fact that many Committee members have heard the information for the first time and this vote should not be taken trivially or on the spur of the moment, if for no other reason than to digest arguments heard, and two weeks waiting shouldn't be a problem. It would be reasonable to expect the Committee can revisit this in a couple weeks. It is important to recognize due diligence and full understanding for the decision-making process. Other curriculum related issues need to be answered as well. Maire asked for; rationale used by schools that have not changed units or workload; information on how increasing English 001 unit value better prepares students for CTE (statement made); how it would increase student success or instruction; TMC has two options for courses other than English 002. Melissa reiterated that more colleges will be moving toward the C-ID compliance mandate of a 4-unit English 002, most students surveyed support the time increase, and she gueried what reason there would be to have different course units. She added that part of bigger picture in the state-wide look at completion rates, is the trend for students to spend less time in developmental sequences and to get to transfer level courses sooner to ensure increase in success rates. Many students drop after their first attempt.

Robin reminded everyone, when working on C-IDs, they can go to ASSIST, then to a particular community college, then to the specific department or major, to find their transferrable courses. Lists of all approved transfer courses will be found in ASSIST under UC Transferable Courses or CSU Transferable Courses. If a course is not on ASSIST, it is not approved for UC or CSU transfer. Robin asked everyone to share this information with their colleagues. Erin Moore noted, in getting C-ID approval, courses have to have been approved within the last five years, from 2008 or preferably more recently. Due to backlog at the state level, Robin doesn't expect to hear back on approvals for a while. She pointed out that once course C-ID submissions are made, the process is in compliance, but she also stressed the importance of vigorous scrutiny to ensure the descriptor elements match and to avoid the hassle of having to redo outlines on rejected submissions.

14. OTHER

Joe reported the Chancellor's Office approved the ECE Transfer Degree. Erin Moore shared words of encouragement based on feedback she has received from the Chancellor's Office. Some narrative revisions had to be made as requested but the Office has been very positive about submissions from the College, stating that materials from here have been really well put together.

Joe encouraged review of the petition to amend class size. The first step is submission to the Curriculum Committee and, once approved, it will go forward to the workload committee. Diane encouraged members to go in and look at other course workload comparisons.
