Discussion: Due to requirements for C-ID descriptors, a statewide discussion was held that resulted in ASCCC President Michelle Pilati sending out a list of schools that require stats as a prerequisite. The TMC recommends a psych stats course that is not currently available here. Marianne was concerned the stats requirement may delay students in moving forward. Maire added that students will delay taking a statistics course. If CSUs or UCs require a prerequisite or if it is shown that it helps students succeed, Joe suggested the Committee could send PSYC 004 back to psychology faculty and encourage them to create their own stats course. However it will be difficult requiring one discipline to change something to work for another discipline. It would also be an extra class for students to take.

Robin pointed out that what is done today will come back at every meeting so a decision is needed, not just on this course, but for any that have prerequisites that haven't been submitted for C-ID approval. Debra noted that financial aid doesn't allow students to take extra courses. Robin added that, theoretically, the prerequisites are the ones required for degrees. Marianne raised concern about additional problems an extra course and semester would create for students to complete their degree. Joe pointed out that there are other avenues a student can take for transfer, they could transfer without a degree or they could get an SCC AA in psych. Students should have options. Robin stated that PSYC 004 is needed to transfer even without an Associate's degree and everyone should consider how this would negatively impact students if the whole curriculum were changed. The state requirement to have every transfer degree in place and have the required descriptor presents challenges. Maire noted the course content for PSYC 004 doesn't state students need stats to pass the course. Joe added that the TMC specifically has MATH 110 as the C-ID descriptor. MATH 110 is the prerequisite at other colleges with equivalent PSYC 004 courses. A new course could satisfy the prerequisite, but students would still need the stats class before getting the degree. As written here, the course can satisfy the PSYC core and degree requirements. It seems there is no other way around what has to be done. Teri opined that it doesn't make sense to complete a TMC in music because it would be unqualified with no chance to succeed. Joe replied it is uncertain what would happen if a TMC isn't in place by fall 2014. Teri continued that a problem at most colleges occurs because the budget doesn't support the programs. Students will continue coming and get AAs.

Robin suggested one option could be to delay compliance for now. Joe expressed hope that local districts will eventually have the option to explain why they'll not have certain transfer degrees, such as lack of resources. He suggested waiting until fall before approving this course modification. Marianne reiterated it would have a big impact for most of the College students transferring to schools that don't have this as a prerequisite and it doesn't seem to have any benefits for the students. Robin pointed out that the Committee will need to postpone other courses that will be coming through similar to this one. Joe is hoping for more clarity when he attends the summer Curriculum Institute. These requirements originated at the legislature.
