Joe reported that some of the athletic type courses may need to be changed from kinesiology to athletics because of the repeatability issue. He clarified that the TOPS code, not what the course is called, is what matters to make a course repeatable. Only intercollegiate athletics or related conditioning courses will be repeatable. He will attend the state Curriculum meeting on Saturday and update the Committee

Curtiss agreed to the suggestion to table modifications for a later decision. Repeatable athletics courses are to be coded. Erin Moore will review the courses with Curtiss as well as other kinesiology courses that have been approved and it may be best to create another resolution. Joe noted that most of the modifications are for theory and practice courses. Top codes can be changed separately on the other courses.

Discussion: Maire questioned how, under Additional Assessment Info, there are practical examinations for a lecture class. Joe responded that there needs to be consistency throughout in evaluating the course outline of record. The assessment should be on student performance objectives. Maire saw it as an activity because it states "practice and apply techniques". Joe pointed out the key issue was the primary focus. Curtiss confirmed that time is spent primarily in lecture and the application practice would be minimal and not be considered an activity course. Maire suggested changing the wording from "practical demonstrations" to "demonstration of proficiency". Marianne noted under section E, general education information "APE local District Req-Health and PE" needs an activity so it should be deleted for general education applicability. Members agreed and Joe made both changes. A: Passed as amended – Unanimous

Discussion: This isn't an activity course and the same APE requirement under Section E needs to be deleted as in Item 8e above. Maire suggested a change in the catalog description to state that upon successful test completion, the student will be knowledgeable in advanced first aid, and will be eligible for a first responder card if they pass the test. A substitution could be done for Fire. Marianne noted her concern that EMT is not degree applicable. Maire suggested discussion is needed for where this can fit, if it can be moved to something other than a 200 level course as it is similar to Fire 128 or EMT 128. A student in a kinesiology major is not going to look for EMT 128, but they will look for a kinesiology course. The flip side is that this course could be made the requirement for EMT 212, rather than offering several different courses for different programs, because they are essentially the same. Maire and Curtiss agreed to future discussion to make this course degree or transfer applicable, rather than just for a certificate. Erin Moore noted that the standard in clinic and hospital settings and for fire stations is the American Heart Association with a move away from Red Cross. Maire responded that an American Heart instructor would be needed.

Because students might assume they will be certified by taking the course, the Committee agreed to add the following statement to the catalog description: "Upon successful completion of the course, students will be knowledgeable in Advanced First Aid and Emergency Care and CPR for infants, children, and adults. Upon successful completion of the appropriate exam, the student will be eligible for certification in First Responder, First Aid and Cardio-Pulmonary Resuscitation." Curtiss pointed out that a student can pass the course even if they don't pass the test. "Required of Physical Education/"Kinesiology" majors was also added. Responding to questioning of the term "word instrument", Joe noted it is CurricUNET language and can't be adjusted to "exam"
