11. REPORT FROM THE CHAIR

- a. ADT update from the Chancellor's Office - University Studies - Liberal Arts for Elementary Teacher Prep (Associate Degree for Transfer)

Marianne recapped: After analyzing this, she felt that it would be too complicated to rush into creating this Associate Degree for Transfer (ADT) now, as there are two or three things that need to be done first: 1) create a new course in education that includes a field work component, 2) probably revise Math 12 and include the Common Core for teaching in elementary school, and 3) possibly a Physics issue. The biggest issue may be the education course as far as who would be responsible for it and the expense associated with the course. In the interim, we'll change the TOP Code and change the title of the University Studies degree for a future agenda item as University Studies-Liberal Studies for Education.

Discussion ensued about whether or not students would have to go into teaching to get the Associates. If so, an education course would need to be created that meets the C-ID, and includes the 45-hour field work component. Would also need a department, such as Child and Family Studies, to take charge of the course, since they currently have a practicum model. A product could then be created for the elementary school. Another option is the Counseling Department, since it has a practicum model as well. For now, changing the TOP Code and title is an easy fix, but moving forward, we want to develop the ADT. It will be a big project given our resources, but valuable for students.

- b. Last date to submit curriculum proposals and secure approvals is March 26

The last day to submit curriculum proposals and secure approvals for new and modified courses this semester is March 26th. With regard to ADT's, the door will be left open for submission.

- c. New ADT's

The new ADT's that just came out and are ready: Biology, Chemistry, and Film/Television/Electronic Media. There are degrees in all of those TOP Codes so we need to create an ADT or lose the degree. ADT's need to be submitted with approvals before June 30th in order to submit to Chancellor's Office (CO)

without C-ID approval. After June 30th, all courses in ADT's with C-ID descriptors will have to be C-ID approved first, prior to submitting to CO. March 26th deadline will be extended for the ADT's.
