Discussion: Erin Moore explained that MATH 023 was listed as a corequisite for ENGR 017. If students had taken Math 023 already, they couldn't register for ENGR 017 because the courses had to be taken at the same time. To correct this mistake, Engineering wanted to add the prerequisite with the option to take MATH 023 concurrently. Marianne thought it was originally intended to be that way but it was a problem with Banner. To clarify, Tina explained that people often interchange the terms concurrency and corequisite. A corequisite has to be set up a certain way in Banner and that is when it creates the problem Erin was talking about. The Chancellor's Office also indicates that corequisite courses need to be taken at the same time. When listed as a prerequisite, MATH 023 can either be taken before or concurrently with ENGR 017 so it won't be a problem for students. A corequisite literally means it has to be taken at the same time.

Students have to be clocked in to these classes to make up time but they are strictly study halls. Leslie agreed reference to assignments and exams don't need to be included. Marianne suggested it needs to be consistent throughout the document. AERO 150 and 151 are positive attendance. We're claiming the time each individual is there.
