Discussion: Erin Moore explained that the changes were from C-ID because of the discrepancy in assignments and essays and tests; the C-ID reviewer wanted "essay test" in assignments, not just essay and test.

- b. (CP15-60) BIO 005 Human Physiology prerequisite, catalog description, objectives, assessments, content, textbooks

Discussion: Robin pointed out an error in the COR; the prerequisite should be Bio 4 <u>and</u> Chem 1, etc.; the Catalog is correct.

Discussion: Robin indicated that in Section E (general education), it should read CSU B2 and B3, since it satisfies both. For IGETC, it should read 5B and 5C. The transfer status in Section K, there is nothing there; it should say that it transfers to UC and CSU. Robin also did not see a "lab manual"; without a lab manual the course will be rejected for C-ID, as well as UC transfer. If one of the textbooks is a lab manual, it should be notated as such. It needs to be clear on the submission that there is a lab manual.

Discussion: Robin mentioned that in Section E there is repetition, such as showing critical thinking twice; also articulation is needed in Section F. Erin Moore said that because it's not a new course, she may have the articulation information and will check. Robin also mentioned repetition in Section K.4.B (shows CSU twice). If this course is to continue to be approved for the CSU GE A1, and IGETC 1C, the course outline needs to show the number of speeches in front of a live audience and professor, possibly placed under 12.C. (The actual number of live speeches will need to be determined, and Robin will find the information.) Otherwise the course is in danger of falling off IGETC 1C and CSU GE A1. It was agreed that further clarification would be needed to proceed with approval, and will be added to the agenda for the next meeting.

11. REPORT FROM THE CHAIR

Currently there is a high school articulation which articulates with some of our courses that are taken at the high school level to get college credit. We may need to have a better handle on the process to ensure that the rigor of the courses taken at the high school meets the rigor that would be transferable to the four-year level. We will probably look to see how other schools address this and establish a process to bridge this gap.

Curtiss will also reach out to other curriculum chairs to see what they do. Robin pointed out that Solano's faculty need to make the decision as to whether or not the High School course is rigorous enough, because students receive credit for the course on the Solano transcript. CSU's and UC's will not evaluate the course as a high-school course, and will assume we've ensured the course is rigorous enough. Leslie recommends the need for a paper trail showing our due-diligence regarding the high-school articulation. Curtiss suggested this possible flow for approval: HS/College instructor > Division > Articulation Officer > Division Rep > CC.
