#### 6. NEW COURSES

a. ENGL 310D/348D Advanced English Skills Lab

1. Action on prerequisite

- M: Erin Duane
- S: Randy Robertson
- A: Course approved.

Discussion: Joshua Scott reported that this is a one unit English lab created to develop a co-requisite instead of a prerequisite course. Other schools have tried this model and it has proven very successful in increasing persistence rates. Dean Maire Morinec asked if English 001 becomes a 6 unit class. Josh Scott responded that it is a 6 unit package consisting of ENGL 001 (4 units) plus ENGL 310D/348D (1 unit), including LR 010 (1 unit). Students could pass ENGL 001 and fail ENGL 310D/348D and go on to the next ENGL 380. Dean Morinec noted that this complicates the student's English course sequences, how do students know what to do? Erin Duane added that some students are in need of this remediation, the assessment placement process is not accurate, it is a path for Basic Skills enrolled students only. The students will be evaluated in the ENGL 001, help will be given to assist them with their ENGL 001 assignments. The students Basic Skills will be limited to half the ENGL 001 class. Debra Berrett noticed that the path options could be confusing and suggested that the catalog needs a flow chart to visually show students their options. Erin Moore asked if ENGL 001 should be listed as a co-requisite to ENGL 310D/348D in the catalog, not the other way around. Joshua Scott confirmed that this correct. She also said it could be labeled as an experimental course. VP AA Leslie Minor added that the college needs to think of a way to market the package carefully. because some courses like ENG 001 is transferable and others may not be transferable. M: Erin Duane motioned to approve prerequisite of eligibility for ENGL 348D of eligibility for ENGL 380

or or a 2.7 GPA and approve ENGL 001 is a co-requisite for English 310D/380D.

Erin Moore reported on the upcoming CurricUNET Meta upgrade which will be active in spring of 2016. She noted that it appears to be more user friendly. If it is working smoothly in the spring it will go live in the fall. She encouraged all committee members to access it using the links provided to test it and provide feedback. She also said trainings will be offered and Chairman Brown noted that it is much more intuitive and useful. Erin Moore did a brief demonstration of the various data fields and added that data is filterable, a very useful feature. She reported that the program is currently being used in San Diego.

## 15. OPEN DISCUSSION

a. Chairman Brown reported a Curriculum subcommittee is needed to develop mechanisms to expunge courses from the catalog. This includes courses that have not been assessed, scheduled, cancelled, obsolete, or combination of two or more. This subcommittee would provide options for course removal from catalog, but not necessarily deleting the course(s), such as deactivation/inactivation. VP AA Minor added that ACCJC is requesting that classes not offered for 2 years be removed from the catalog, not 5 years as previously reported. She also stated that creating an alternate assessment is not an option. Committee members Erin Duane and Joshua Scott volunteered for this subcommittee. If you have input please contact the subcommittee members. Chairman Brown suggested the subcommittee provide options for divisions, schools, instructors to support identified courses for possible extensions and determine how long a course with the criteria above be listed in catalog before deactivation or deletion.
