Lisa-there is a lab, but not repeatable.

Maire-states PHOT 130L is not listed.

Neil-states the lab was offered on Fridays which students were not all able to attend.

Maire-states her concern in regards to additional 3 hours/week (PHOT 130L) for the students when there is a built in lab for this course with assigned time.

Margherita-asks if the labs cover same material?

Neil-states how labs are offered and history of including the lab versus previous drop-in lab.

Anthony-asks about adding more lab time into course.

Margherita-asks if student can take PHOT 130L alone?

Curtiss-verifies it is a co-req and cannot be taken alone.

Neil-mentions the faculty member found this to be the recommended model that is used by other colleges.

Maire-concerned that the lab hours are included in the transferable course and asks how CC can approve a co-requisite (PHOT130L) when it has not been approved.

Marianne-language is not clear in COR.

Curtiss-provides information about 3 units versus making a 4 unit course and possible articulation road blocks. Margherita-how do lecture and lab hours compare to UC's?

Virginia-nontransferable lab course while enrolled with transferable lecture/lab course-stating the question of what's being discussed. If students want additional lab time should this be a co-requisite? Can a lab be a co-requisite to another lab?

Maire-this does not fit based on past curriculum history.

Neil-states we have a lab that can be taken, but is not repeatable. PHOT 130L provides the option for additional lab time. Currently, lab is not a co-requisite.

Maire-motions to table proposal and explore other options with faculty member, by finding a way to include lab with courses or option for other labs, make it optional.

Margherita-asks if course could be lecture only and have a lab course?

Neil-asks were these concerns discussed in tech review? No
