REPORT FROM THE CHAIR

Chair Robin Arie-Donch distributed a copy of a letter to the Local Academic Senate President, over the signature of Kate Clark, Academic Senate President, dated December 2, 2004. Also distributed was information on proposed revisions to disciplines (Master's). Ms. Clark in her letter advised two hearings have been scheduled for those who would like to express their opinions or the opinions of those they represent as follows: January 28, 2005, San Francisco Westin, and February 18, 2005, Ontario Airport Marriott. The Academic Senate for California Community Colleges is responsible for recommending to the Board of Governors (BOG) changes in the Disciplines List for Minimum Qualifications for faculty hired by California's public community colleges. The next step in the process is for interested parties to review the proposals. Delegates attending the Spring 2005 Plenary Session to be held April 7-9, 2005, will vote on revisions that will ultimately be forwarded to the BOG for final actions.

The Academic Senate is in the process of discussing the proposed changes to the GE structure. A vote on the PE requirement in the GE structure will be taken by the Curriculum Committee at their first meeting in February 2005. A vote taken later would mean that the information cannot be included in the new Catalog.
