#### **NEW COURSES**

a. (CP-07-15) COUN 148C – Disability and Success

- 1) Action on advisories: SCC minimum English and math standards; primarily for students with disabilities.
- 2) Action on course.

It was moved by Brad Paschal and seconded by Kathy Rosengren to approve action on the advisories as presented.

The motion carried. Paris Watson abstained.

The question was raised if this course can begin in fall 2007. Donna Vessels advised she will clarify this and report back to the committee.

There was discussion if 56 total weekly hours was a reasonable expectation for this one-week course. Action was taken to change the course format and duration from one week to two weeks, (24 lecture + 4 labs) and to add to 9b. Other Catalog Information, a pre-reading component, e.g., **A pre-reading course assignment will be required.** It was clarified that students will get the pre-reading assignment in their pre-course meeting for the course.

There was agreement to change 11. Methods of Evaluating Student achievement as follows: ~~Students will be evaluated by traditional testing methods.~~ Given a scenario by the instructor, students will also be evaluated on their ability to use critical thinking skills to conduct certain surveillance techniques to develop an arson suspect.

There was agreement to add the standard critical thinking statement to the course outline.

Roy Pike advised this course has not been offered before; therefore, Section F. Articulation Information (c.) will be changed as follows: ~~Yes, Colleges;~~ **Has not been offered.**

- a. (CP-07-16) Agriculture Business – Delete program.

- b. (CP-07-05) OT Job Direct Certificate: Medical Office Assistant – Change the title, deleting 3 required courses, adding 6 required courses and changing the total unit value from 14.5 to 17 units.

It was moved by Ann Willer and seconded by Maire Morinec to approve the program major modifications as presented.

The motion carried unanimously.

#### ***REPORT FROM THE CHAIR***

Chair Erin Farmer advised she will be reviewing the changes to Title 5 affecting curriculum and reporting on them at a future meeting.

Chair Farmer reported on the curriculum updates from the Academic Senate Plenary, which took place this last weekend (April 21-22, 2007) in San Francisco. Erin advised she attended breakout sessions pertaining to curriculum, while Academic Senate President, Gail Kropp, attended those related to governance and basic skills.

For distance education courses, separate approval requirements are clarified in the new Title 5 language, a copy of which was distributed to the committee members. Separate approval applies to all courses in which distance education replaces any face-to-face time in the classroom, not just when 51% of the course is taught online. SLOs assessment will require meticulous attention to how methods of evaluation/assessment are adapted to online course delivery modes.

Erin reported she attended a breakout session on the range of types of courses (credit, noncredit, community service and contract education) and the curriculum processes appropriate to teach. Like distance education, noncredit is a rapidly growing area of curriculum, largely due to changes in the way the courses are funded. The committee will need to make sure that our curriculum processes keep up.

Chair Farmer concluded by saying she will be attending the Senate's Curriculum Institute this summer and will participate in intensive workshops on noncredit, distance education and SLOs. This year, because so much of the institute's offerings are SLOs related, the College's SLOs Coordinator, Tracy Schneider, will also attend. When appropriate, Tracy will be invited to a curriculum committee meeting to discuss SLOs.

### ***REPORT FROM THE VICE PRESIDENT***

There was no report from Dr. Marjorie Carson, Interim Vice President, Academic Affairs.

### ***OPEN DISCUSSION***

WebCMS still cannot be accessed from off campus. It currently does not interface with Banner. The question was raised about the research done on CurricuNet last year. Chair Farmer advised that, according to Vice President Field, this software does not interface well with Banner. The committee suggested that they might want to invite vendors of software that do interface well to a meeting after Banner has been implemented. It was also suggested that we contact other institutions using Banner to see what they use for their curriculum program.

### ***ADJOURNMENT***

There being no further business to come before the committee, it was moved by Kathy Rosengren and seconded by Maire Morinec to adjourn at 3:05 p.m., to meet again Tuesday, May 8, 2007, 2:00 p.m., in the Board Room. This will be the last committee meeting for the spring 2007 semester.
