REPORT FROM ARTICULATION OFFICER

Robin Arie-Donch, Articulation Officer, reported that she submitted for the second review cycle the U.C. minor changes. Robin asked the committee when she gets the CSU/G.E. and U.C. transferability results back if the committee would like to see them. The committee responded that they only want to see the exceptions, and things that are not routine may be put on the agenda for information.

REPORT FROM THE CHAIR

Chair Erin Farmer reminded the committee that October 29 is the deadline for the November 13, 2007, meeting. It is possible not all of the curriculum review courses in Humanities will have been received; therefore, some of this information may have to fall into the last meeting.

Chair Farmer reminded the committee of the CurricuNet demonstration scheduled in the Board Room on Tuesday, October 30, 2007, beginning at 1:30 p.m. She asked the committee to get a replacement if they cannot attend.

Chair Farmer reminded the committee that the online addendum forms should go to her first before they go to the Curriculum Office. This will allow her to review and make suggestions for possible change, etc., before the committee sees them. The forms used in the past are still viable. Erin stated she would need this information before the Monday deadline of regular curriculum items.

Jenn Branaman, vocational student representative, asked the committee members if they thought their students would be interested in a Handbook for Students which would assist students in keeping track of when their clubs meet, sports activities, etc., for a price of \$2.00 each. The handbook will have the ASSC members' pictures on it which will facilitate students in knowing who their representatives are. The committee felt it would be well received and used by students.

Chair Erin Farmer acknowledged Judy Spencer and her service to the Curriculum Committee for the past seven years as the official note taker. This was Judy's last meeting with the committee due to her recent promotion from the Office of Academic Affairs to the Superintendent/President's Office, effective November 1, 2007. Erin presented to Judy on behalf of the committee a parting gift and expressed how much her work with the committee has been valued and that she will be missed. Judy thanked the committee for their thoughtfulness and expressed how much she has enjoyed working with the committee, and that all she has learned about curriculum will be carried forward as she moves "next door" to the President's Office.

REPORT FROM THE VICE PRESIDENT

Interim Vice President Kathy Rosengren stated that because there is a flurry of last minute curriculum activity going on, it may be that we must also take special case material to our last meeting. We are desperately trying to resolve a long-standing grievance. If we are able to do that, it will necessitate course modifications that must go into effect next fall. This is a slight modification of our own rules, but Kathy stated she is hopeful the committee will be able to look at this information favorably in order to not lose the momentum of moving courses forward.

OPEN DISCUSSION

Dean Robert Johnson, Career Technical Education Division, raised the issue about the residency requirement for the Associate Degree. Presently the Catalog on page 39 states: "At least 12 semester units must be completed at Solano Community College." There is no requirement in the A.S. or A.A. degrees that any of the 12 units must be in the major. The Certificate of Achievement states: To be eligible for a Certificate of Achievement, at least six semester units in the field or a closely related subject must be completed at Solano Community College." Bob would like to suggest we include a similar statement for the Associate Degrees also.

Dean Johnson stated he is raising this issue because he recently signed a series of substitution forms for an Ornamental Horticulture student for classes she completed at DVC. The student will be requesting an Associate Degree from SCC without taking any Horticulture classes at SCC.

Chair Farmer asked Dean Johnson to prepare a statement that shows how we deviate from the norm and document who does not, and she will take the topic of discussion to the Academic Senate. The committee will also discuss the issue in more detail at a future meeting.

ADJOURNMENT

There being no further business to come before the committee, it was moved by Leslie Rota and seconded by Quentin Carter to adjourn at 2:45 p.m., to meet again Tuesday, November 13, 2007, 1:30 p.m., in the Board Room.
