2. Update on the Faculty Technology Group

Svetlana asked what was meant by number three. Dale said number three meant that an Instructor could not teach a complete course on a site where SCC has no access to the course. An SCC Instructor cannot have a Canvas shell that is empty or shows no activity during the semester.
