- Uses the term "Accreditation Board" throughout the report when the appropriate title should be Accrediting Commission for Community and Junior Colleges (ACCJC).

### Page 1:

#### Marie Young

• <u>Grand Jury Actions</u>: Interviewed administrative staff. What are the titles of the employees interviewed?

#### Pam Keith

• **Background Summary (1st paragraph):** Construction and renovation funding for all campuses is through the Measure G construction bond in 2004. **Should be 2002.**

Rosemary Thurston

 Background Summary (2<sup>nd</sup> paragraph): It states the commission placed the college on probation in 2007, which is an incorrect. The college was placed on "warning".

#### David Brannen

**Background Summary (2<sup>nd</sup> paragraph):** The California State College Accreditation Board. There is no such entity. Should be Accrediting Commission for Community and Junior Colleges - Western Association of Schools and Colleges

### Page 2:

### Marie Young

<u>1<sup>st</sup> paragraph</u>: States if matters are not resolved by December 31, 2009, the college would lose its accreditation and financial aid. Is this statement correct? It does not appear accurate. (See page 4, 2<sup>nd</sup> paragraph –date June 30, 2009)

#### Rosemary Thurston

- <u>Next paragraph-bullet one</u>:
- The two systems have not been able to reconcile the data. Is this true?

• The June 30, 2008, year-end Financial Report could not be finalized because of an approximate \$1 million discrepancy. This statement is not true.

## <u>Next paragraph-bullet one</u>:

• Bullet number one mentions as of January 26, 2009, the financial report had still not been finalized. Since this statement is present in the report, the report should also note that the CBO was not available to complete the report because she was still on paid administrative leave and similar reports by the CBO were submitted in a timely manner for the prior fiscal school year.

# <u>Next paragraph-bullet two:</u>

• There was an inappropriate transfer of funds from the Measure G Bond fund to the General Fund in order to cover expenditures that should have been paid from the General Fund. This is not true.

# Marie Young

<u>Next paragraph</u>: It states that the new interim Superintendent/President requested an "independent investigative report", which the Governing board approved on a split vote (4?-2). (Was Denis present at this meeting?) It was not an investigative report, but a review of the district's internal controls, an examination of external reports and performance of a fiscal health analysis. Special Trustee Tom Henry called it an "independent external review."

• <u>Next sentence</u>: It states the Interim Superintendent/President also suspended the financial director. The title (financial director) of the person is incorrect. The Board was informed that she was placed on paid administrative leave. Since this is a personnel matter, how is it relevant to this report?

• <u>Bullet comments-#4</u>: Excessive turnover in leadership positions within the College, for example, the five Vice President positions have been filled by 14 people during the last five years. Is this true?

• <u>Item 2)</u>: States the College purchasing agent; however, the EDMAC report does not refer to "the purchasing agent" relative to this issue.

• <u>Bullet comment next to last on page</u>: The final adoption of the budget and the books not being closed was after October 6, 2008. It should be stated that the staff failed to accomplish this in the absence of the CBO.

# <u> Page 3:</u>

*Jim Claffey David Brannen Tom Henry – taken out of context – not consistent with EdMAC Report.* 

• <u>Item #2:</u> After two thefts from College safes, money is now being secured in metal lockers located in a hallway. The Board didn't get this report. This allegation was made in the paper. If true, getting information from local papers, which are necessarily accurate.

First Bullet Comment: The second sentence states "the Board has allocated \$937,234 for this year's Retiree Health Benefit"-This is not true, it was deposited years ago (2005-06 fiscal year). According to the Board literature that I received at Board meetings, the amount allocated was \$917,234 and it has earned interest to reach the total it stands at now. Further, the college is not required to fund the liability, but instead book it. However, it is a Board goal and we are working on a plan to start funding the liability.

 <u>Third Bullet Comment</u>: There is a \$217,138 charge for maintenance paid from the Measure G Bond Funds. (This was an accounting error that has subsequently been corrected.) Why is this in the report?

• <u>Fourth Bullet Comment:</u> The College inappropriately transferred \$1,045,105 ..... This entire paragraph is incorrect: The recent newspaper article cleared up this matter and therefore it should not be even mentioned. The press release by the chair of the CBOC cleared up this matter.

• <u>Next Paragraph:</u> The above issues were all discussed in the EdMAC Report .... There was no direction to recruit a CPA. It has not happened and even the current job description states CPA <u>preferred</u>. Further, the Board did not direct this action.

## Rosemary Thurston

• <u>Next Paragraph:</u> In the latter part of 2008, one of the College Board members submitted an article to the Vacaville Reporter.... What is the relevance to this report?

## Marie Young

• <u>Next Paragraph:</u> On January 7, 2009, the CCC State Chancellor .... The date should be January 5, 2009, not January 7, 2009.

 <u>Next Paragraph</u>: In December 2008, the Chairperson of the Board of Trustees met with the Interim Superintendent/President .... The date should be January 5, 2009. The Chairperson of the Board of Trustees met with the Interim Superintendent/President as directed by the Board in closed session on December 17, 2008. The rest of the paragraph is completely untrue. <u>Tom Henry plans to respond.</u>

• Last paragraph on page 3 ending on page 4: I see the Executive Committee as a very important committee on campus and find it alarming that no minutes were available for October 2008 – January 2009, when the Interim Superintendent-President chaired the committee.

• <u>Second Paragraph:</u> The second sentence sates the College has until June 30, 2009 to prove to the Accreditation Board why it should not lose its accreditation. This is a contradiction with an earlier comment at the top of page 2, which sates December 31, 2009. Which is correct? The comment on the top of page 2 was made by the Interim Superintendent President. Dates need to be checked.

What about the 109 other schools as opposed to "one of the few community colleges within the state who credits directly transfer ...." We are following the report. We may need to employ counsel for a response. Maybe we are saving money by reducing liability to the college with litigation.
