# Resolution No. 2010-103

### RESOLUTION OF THE SOLANO COUNTY BOARD OF SUPERVISORS RECOGNIZING SOLANO COMMUNITY COLLEGE FOR THEIR EFFORTS TO COMBAT THE SPREAD OF THE H1N1 NOVEL VIRUS

WHEREAS, on April 26, 2009 the U.S. Department of Health and Human Services determined that a nationwide Public Health Emergency existed relative to the Swine Flu pandemic; and

WHEREAS, on April 28, 2009 Governor Schwarzenegger proclaimed a State of Emergency in California to support and facilitate our State's response and mitigation efforts associated with the H1N1 Swine Flu pandemic; and

WHEREAS, on May 5, 2009 the Solano County Board of Supervisors declared a local health emergency in response to the H1N1 pandemic; and

WHEREAS, Solano County residents' demand for information and support exceeded the capacity of the Solano County Department of Health and Social Services; and

WHEREAS, the demand for vaccination by Solano County residents could not be met utilizing only County personnel and resources; and

WHEREAS, community based mass vaccination clinics were established to serve the needs of Solano County's most vulnerable populations; and

WHEREAS, Solano Community College partnered with the Solano County Department of Health and Social Services to provide support in the endeavor to educate and vaccinate and thereby protect thousands of Solano County residents.

NOW, THEREFORE, BE IT RESOLVED, that the Solano County Board of Supervisors does hereby recognize Solano Community College for partnering with Solano County in combating the spread of the H1N1 novel virus.
