UNADOPTED MINUTES January 12, 2011

1. CALL TO ORDER

A Special Meeting of the Solano Community College District Governing Board was called to order at 6:30 p.m., on Wednesday, January 12, 2011, in the Administration Building, Room 626, at 4000 Suisun Valley Road, Fairfield, California 94534, by Vice President Young.

4. APPROVAL OF AGENDA

Moved by Trustee Claffey and seconded by Trustee McCaffrey to approve the Agenda as presented. The motion carried unanimously.

5. COMMENTS FROM MEMBERS OF THE PUBLIC

Vice President Young recognized Ms. Maria Bitagon from the Filipino-American Chamber of Commerce in Vallejo, who requested to present a scholarship award to Solano Community College. Ms. Bitagon introduced Councilmember, Mr. Hermie Sunga. Together, they presented to President Laguerre, Vice President Young, Dean Lucia Robles, and Dean Thomas Kea, a check in the amount of \$500 benefitting students in the Business and Career Technical Education Division.

Councilmember Sunga stated what a great friend Solano Community College is to the Chamber and how much the partnership is valued.

Dr. Jowel Laguerre stated, "Without partnerships within our community, we are not able to fulfill our mission." The Annual Business Symposium that takes place at the College helps Solano College be exposed to the business community; and, of course, the business community receives exposure to the College.

Ms. Bitagon announced that Solano Community College has been nominated as the 2010 Business of the Year by the Vallejo Chamber of Commerce. She wished the College well. The winner will be announced at the Annual Banquet Installation on Friday, January 14, 2011, McCormack Hall in Vallejo.

6. REPORTS (NO ACTION REQUIRED):

(a) Anatomy of a Budget

Facilitated by Roy Stutzman, Consultant, Finance and Administration

Before his presentation, Mr. Roy Stutzman highlighted the impact of Governor Jerry Brown's 2011-12 proposed state budget on California Community Colleges.

Mr. Stutzman began by stating that Governor Brown is proposing a \$400M budget reduction to California Community Colleges, which equates to a 6.8% budget reduction. This cut translates into approximately 400,000 students losing access to classes. The proposed \$10 per unit fee increase would generate \$110M for the colleges to support an additional 50,000 students. With the fee increase, as many as 350,000 students could lose access to a community college education. The \$10 per unit fee increase would raise student fees from \$26 per credit unit to \$36 (38.5%). Mr. Stutzman stated that when you are looking at a \$25B statewide problem, \$400M doesn't seem like much, but it significantly hurts us as an individual community college.

Mr. Stutzman began his presentation by alluding to the preface as contained in the "Anatomy of a Budget", which reads as follows:

"The state of California is facing the worst financial crisis in its history. Fiscal stewardship and accountability become even greater priorities for local Community College Boards. The probable continued reduction in state and local funding compounded by increased costs for employee benefits, insurance, utilities, etc., and the demand by more students to enroll will place colleges in the unenviable position of attempting to do even more with even fewer resources. Decisions around what activities will be funded and how districts choose to allocate scarce resources become more critical in today's fiscal environment.

The financial realities facing California Community Colleges has created an environment in which Trustees are sometimes drawn into the temptation of making managerial decisions or are overwhelmed by the drastic situation and not properly engaged in leading the college district. Trustees are reminded that Boards establish the 'what' to be accomplished and do not decide on the 'how' something is to be accomplished. In order to assure the 'what' is being accomplished, the Board needs to develop measurements (benchmarks) that can be used to determine if their goals are being effectively accomplished.

Accurate and reliable financial reporting becomes even more critical when resources are severely limited. Reports are well constructed when they are clear, concise and address the needs of specific users. The most helpful reports are those indicating the direction in which an institution is moving. These reports reflect trends as well as the current state of affairs.

Timely and accurate financial reporting relies upon an accounting structure designed to meet the needs of the institution. The structure provides the framework for generating the types of management information most useful for the District. Accounting rules established by the California Community Colleges Chancellors Office *Budget and Accounting Manual* provide the structure under which all districts must operate. The purpose of the reference material presented in this manual is to provide information to assist the Solano Community College District Board achieve its full measure of effectiveness as 'custodians of the public trust.'"

Trustee Keith arrived 7:09 p.m.

Vice President Young thanked Mr. Stutzman and Vice President Ligioso for their comprehensive report on the "Anatomy of a Budget."

Vice President Young announced that the Board would be holding conference with legal counsel to discuss litigation between Roth v. Solano Community College District in Closed Session.
