• Intertribal Council Solano County California Night Celebration – Janet Kendall

Dr. Jowel Laguerre, Superintendent-President, introduced Ms. Janet Kendall from the Intertribal Council of Solano County. Ms. Kendall began by stating for the Intertribal Council, the evening was a home coming of sorts. Although the Pow Wow has been held in Vallejo for eighteen years, they are now coming home to lands that were first settled by tribal people who certainly held gatherings and celebrations under the same oak trees that surround the campus.

These grounds are also the home to this great college. We know that education has always formed the heart and soul of all human cultures. It is the knowledge we have of ourselves that defines our individuality. It is our knowledge of others that defines our commonality. We are all more contented people when we are together. We are all more fulfilled people when we celebrate together. It is simply impossible to be sad, hateful, or angry when you sing, dance, and interact in friendship. That is the purpose of a Pow Wow.

It is no accident that many of the great Pow Wows today are held on college campuses, such as Berkeley, UCLA, and Stanford. Now Solano Community College joins this elite group. Colleges are where people come for knowledge and understanding. Knowledge and understanding have always been the cure for prejudice and oppression.

For the 18 years the Intertribal Council held two-day gatherings in Vallejo and did not use any city funds. All fees and permits were paid and the Council abided by all rules and regulations. Ms. Kendall stated the Council hires support services for the Wow. The Council purchases food and supplies. The Pow Wow fills the local hotels, puts patrons I restaurants, and sells gas at local stations. People travel from all over California and from many locations in the U.S. Canada, Mexico, and Central America to attend our Pow Wows. Alcohol and drugs are not allowed at Pow Wows. We respect the grounds. We dance and celebrate and always leave the area clean and undisturbed.

Ms. Kendall concluded by saying that the night officially begins this new venture with an overwhelming feeling of gratitude and excitement. The Intertribal Council thanked Dr. Laguerre, the Solano Community College Governing Board, Mr. Curt Johnston, Mr. Dwight Calloway, Ms. Shemila Johnson, and Ms. Janice Eaves for working so hard and so closely to make this Pow Wow happen. "We are so happy to finally be home!"

After retirement, she agreed to help the Educational Foundation to get a jump start again, and we thank her for her efforts. WHEREAS, As a leader and advocate for all, Dee served as the first female Superintendent of Schools in Solano County in its 161-year history; and

(c) <u>Contract Award to LPAS for Building 1200 Theater Renovation Project Pre-Design and Start Up Services</u>

Mr. Leigh Sata, Executive Bonds Manager, stated this is the beginning of a larger contracted, provided by legal counsel. Board approval was requested for contract award to LPAS to provide pre-design and start-Up services for Building 1200 Theater Renovation Project (Phase I) and Addition (Phase II). Upon completion of the pre-design phase, the District will bring to the Board a full contract for approval. Request for Qualifications & Proposals was issued in October 2013, and on October 29, 2013, District received 16 Statement of Qualifications. The Selection Committee reviewed each Statement of Qualification and evaluated each respondent. A shortlist of candidates was completed on November 4, 2013, and it included top four qualified firms. All four firms were interviewed on November 8, 2013, and their fee proposals were opened following the Committee's review of all interviewed candidates. The Selection Committee recommended LPAS as the architect for Building 1200 Theater Renovation Project. Total fee for this contract is \$40,000.

Moved by Young seconded by Trustee Keith to approve the Contract Award to LPAS for Building 1200 Theater Renovation Project Pre-Design and Start Up Services. The motion carried unanimously.

(d) <u>Contract Award to Enlight Energy Efficient Lighting, Inc., for Implementation of District Lighting Energy Efficiency Project</u>

Mr. Leigh Sata, Executive Bonds Manager, stated this contract is for Phase One of a two-phase project. Savings on energy will be a result of this contract. Board approval was requested for contract award to Enlight Energy Efficient Lighting Inc., to provide scope validation, design, and installation of energy efficient lighting and controls at SCCD Fairfield Campus, Vacaville, and Vallejo Center sites. Request for Proposals (RFP) was issued in October 2013, and on November 6, 2013, the District received five Statement of Proposals. The Selection Committee reviewed each Statement of Proposal and evaluated each respondent based on qualifications and cost proposal requirements set forth in the Request for Proposal document. The Selection Committee recommended Enlight as the contractor for the implementation of District Lighting Energy Efficiency Project. Total fee for this contract is \$592,833.

Moved by Thurston seconded by Trustee Brown to approve the Contract Award to Enlight Energy Efficient Lighting, Inc., for Implementation of District Lighting Energy Efficiency Project. The motion carried unanimously.

(e) <u>Contract Award to Accountemps, A Robert Half Company</u>

Mr. Leigh Sata, Executive Bonds Manager, stated that he needed someone quickly before the hiring process could be started for support staff in the Bond Office. Board approval was requested for a contract award to Accountemps, a Robert Half Company. Accountemps specializes in providing accounting, financial, and administrative staffing solutions. An interim bond "Business Operations Coordinator" is required to fulfill administrative and business duties while the District hiring process for the permanent position is carried out. For a period beginning on Monday, September 16, 2013, and ending on Friday, April 4, 2014, a total of 30 weeks, a temporary position will be created at a rate of \$33.00/hour, which includes all benefits and fees to the Robert Half Company. The contract is hourly and will not exceed \$39,600.

Moved by Thurston seconded by Trustee Young to approve the Contract Award to Accountemps, A Robert Half Company. The motion carried unanimously.

(f) Contract Award to Ninyo and Moore for due Diligence Report

Mr. Leigh Sata, Executive Bonds Manager, presented the request for contract award to Ninyo and Moore to provide a Phase 1 Environmental Assessment (ESA) for a site contiguous to the existing Vallejo Center. A short form contract is part of this approval. The scope is described in the proposal and the work will be complete within three weeks. Total fee for this contract is \$3,500.

Moved by Thurston seconded by Trustee Martin to approve the Contract Award to Ninyo and Moore for due Diligence Report as presented. The motion carried unanimously.

(g) <u>Change Order No. 01 to GradeTech Construction for Vacaville Parking Lot Expansion Project</u>

Mr. Leigh Sata, Executive Bonds Manager, presented Change Order No. 01 to GradeTech Construction for the Vacaville Parking Lot Expansion Project. The Change Order Request Breakdown and the Change Order Summary amounted to \$50,984.96.

Board approval was requested for Change Order No. 2 to the SunPower Corporation base contract for the Photovoltaic projects. The Change Order Requests Breakdown and Change Order Summary amounted to \$435,979.

(j) Sabbatical Leave Academic Year 2014-2015

The Sabbatical Leave Committee recommended that the following instructors be granted Sabbatical Leaves for the 2014-2015 academic year: Laura Pirott (Fall 2014); Zachary Hannan (Spring 2015); Theresa Pearson-Bloom (Full Academic Year 2014-2015). The estimated fiscal impact for these sabbatical leaves amounts to \$120,000.00.

Moved by Thurston seconded by Trustee Keith to approve the sabbatical leaves for the academic year 2014-2015 as presented.

(k) <u>Memorandum of Understanding between Solano Community College District and</u> <u>Fairfield-Suisun Unified School District for Establishment of Early College High School</u>

Dr. Shirley Lewis, Chief Student Services Officer, together with Sheila McCabe, Ed.D., Director of Secondary Education at Fairfield-Suisun Unified School District, presented the Memorandum of Understanding between Solano Community College District and Fairfield-Suisun Unified School District to plan the establishment and operation of an Early College High School located on the Fairfield campus of Solano Community College starting in the fall of 2014. This MOU is the culmination of a collaborative partnership since fall 2010. With Board approval, this MOU will be presented to the Fairfield-Suisun USD for their approval on December 12.

Dr. McCabe expressed her excitement. Currently, there are sixty (60) students that are expected to enroll as freshmen, offering them a variety of choices.

Moved by Trustee Honeychurch seconded by Trustee Brown to approve the Memorandum of Understanding between Solano Community College District and Fairfield-Suisun Unified School District for Establishment of Early College High School. The motion carried unanimously.

(a) Facilities Reorganization – Addition of Position

Dr. Jowel Laguerre, Superintendent-President, presented a proposed reorganization plan to better serve the Institution and improve customer service. A new position, Assistant Director,

Facilities/Energy Management (Range 42), was included. The position was vetted through the Superintendent-President's Cabinet, Position Control Review Committee, and Shared Governance Council. This position will be partially funded by the Energy Savings Projects. The reorganization chart for the Facilities group was available for review.

Moved by Trustee Young and seconded by Trustee Keith to approve the Facilities Reorganization with the addition of a position as presented. The motion carried unanimously.

15. INFORMATION ITEMS – NO ACTION REQUIRED

(a) <u>Fiscal Services Reorganization – Addition and Proposed Upgrade of Positions</u>

Yulian Ligioso, Vice President, Finance & Administration, presented a proposed reorganization plan to better serve the Institution and improve customer service. New Positions Accounting Specialist II, Accounts Payable (Range 14); Specialist (Range 15); Proposed Upgrade (CSEA in agreement with proposed upgrades) Payroll Analyst (Lead) - (Range 20); Payroll Technician (Range 13, Part-time 50%), and Senior Accountant (Range 21). An organizational chart for the Fiscal Services group was reviewed.

This item will return to the Board for approval December 18 pending a positive vote and ratification of CSEA.

(b) <u>Annual Financial Report – CCFS-311 for Fiscal Year 2012-2013</u>

Yulian Ligioso, Vice President, Finance and Administration, presented the 2012-13 Annual Financial and Budget Report–CCFS-311. The report has been filed as required with the California Community Colleges Chancellor's Office. A \$6.2M balance is the direct result of Proposition 30, but is a temporary measure. This income tax is ending in six years and the sales tax ends in four years. Hopefully, the state will have increased their revenue stream by then.

VP Ligioso stated that we met the 50% law, which means we are mandated that half the costs of education have to go into classroom, and we met that requirement.
