(b) <u>Academic Senate</u>

On behalf of Dr. LaNae Jaimez, Vice President David Williams gave the following report:

- SCC hiring processes are well underway for the 12 new FT Faculty hires. Many of the job descriptions have been posted and the interview committees are hard at work developing questions for the screening process and interviews. Academic Senate is grateful for the addition of a FT Chemistry faculty position.
- The Distance Education Committee, a subcommittee of the Senate, welcomes a new coordinator this semester, PT Faculty member John Perez.
- The Senate approved changes to the Local/Non-Transfer General Education requirements as recommended by the Curriculum Committee. We believe the changes will benefit SCC students by making the local GE requirements easier to understand and follow.
- Spring 2022 Senate goals include,
 - o Hiring and training faculty mentors for the to-be-hired FT faculty
 - Continue working on DEI matters related to curriculum and our institutional practices
 - Help plan and support the return to campus
 - o Complete a review and update of the Academic Senate ByLaws, the Peer Review handbook and Accessibility Handbook for Faculty.
 - Support the work of the Guided Pathways coordinators.
 - o And other things that I will share as the semester progresses.
- I would like to give a hearty thank you to the Professional Development/Flex Cal committee for providing another Flex event full of a variety of meaningful, useful and fun events.
 - Senate and the administrators spend an afternoon session exploring gratitude and its benefits. The outcome was a shared goal to practice and share our gratitude at

SCC during the spring semester. My hope is that this will become an ongoing practice.

- Two sessions were held for the upcoming interview committees, one provided information and training on how to write equity minded questions that provide useful information about candidates and the other clarified HR regulations for the interviews in hopes of standardizing our practices.
- o School meetings allowed us to reconnect with our deans/colleagues.
- o And, of course, trivia with VP Williams is always fun and draws a nice crowd.
- I wish you a happy new year full of gratitude for the things that we do have and that we are able to do for ourselves, our families, our SCC students and the SCC community.

(c) <u>College Governance Council</u>

Superintendent-President Esposito-Noy reported that CGC will resume meeting on January 26th. We will ask that they review the proposed policy and procedures on remote work which we will then bring to the Board. The meetings will continue to be held remotely, assuming the committee passes the resolution. This is the safest and most accessible way to meet.

(d) Superintendent-President

Superintendent-President Esposito-Noy provided the following report:

- The semester began on Tuesday with the majority of classes meeting remotely for the first 5 weeks.
- We have continued to see an increase in the number of positive COVID tests reported by employees and are adhering to public health and Cal OSHA guidelines on isolation and retesting before returning to campus.
- Our enrollment as of Tuesday was: headcount- 8,048 compared to 8,425 in 2021; FTES- 2,641 compared to 2,857 in 2021. Like most districts our enrollments are down.
