# **Project Updates**

April 15, 2011



This update provides a current overview of the Measure G Bond program. Current activities of the bond program range from design and construction, through project closeout. Project status for the third quarter of the fiscal year 2010 / 2011 is as follows:

### **PROJECTS IN PROGRESS:**

### ATHLETIC FIELDS RENOVATIONS

Project is approximately 99.5% complete, with closeout in progress. One final DSA required structural test's required for the installed bleachers to be completed for DSA certification. Final Close-out is scheduled for completion Spring / Summer 2011.

### **BUILDING 600 - ADMINISTRATION**

Preliminary programming/design meetings have been conducted with the Administration, Institutional Advancement and Human Resources Departments. Additional meetings have been scheduled with Finance & Business Services and Research and Planning, to further determine space needs with the departments. Programming and preliminary design for Building 600 will be completed Spring / Summer 2011

### **BUILDING 1300 REMODEL FINE ARTS**

Plans and specifications for the 12,570 square foot building have been submitted to DSA for review. The project is scheduled for Bidding and start of Construction Spring / Summer of 2011. The project will use Building 1100 (portables) for swing space during the 12 month construction period and work to prepare the swing space is in progress. Building 1100 will be scheduled for demolition after the Building 1300 Fine Arts is complete and all occupants of the swing space have been moved back into the renovated facility.

### POLICE SERVICES - FAIRFIELD CAMPUS

Facilities has met with the Police staff to review needs for moving the Department to a new long term temporary space in Building 1800B. The staff is currently being housed in an office swing space located in Building 1800B on a short term temporary basis, while the long term solution is being studied. The District and Kitchell are meeting to determine the phasing of work for the long term temporary Police Station.

### FAIRFIELD IRRIGATION PUMPING & DISTRIBUTION SYSTEM

The project consist of two phases of work, demolition and removal of existing irrigation pumping station equipment and controls and the installation of new pumping station equipment and controls. The work is approximately 99% complete with new installation. Start up and testing of the new system was begun the week of April 18, 2011. Project is on schedule to complete work within weeks.

### PROJECTS SUBMITTED TO THE STATE:

The following projects have been submitted to the State for funding:

### BUILDING 1200 THEATRE – FINAL PROJECT PLAN (FPP)

Program, schematic design and 95% estimate are complete based on renovating the existing building. The District has submitted an FPP to the State for 100% funding due to health and safety issues. Design work has been suspended until the State Bond is passed in 2012.

### BUILDING 100 LEARNING RESEARCH CENTER (LRC) – FINAL PROJECT PLAN (FPP)

In 2007 the District submitted to the State, an FPP for the renovation of the existing Library Building. The District, with a change of direction in 2009, submitted to the State an FPP for a replacement Learning Research Center (LRC). The District increased its matching funds offer for the new building to move up on the State funding priority list. On hold pending a State Bond in 2012.

### **RE-PRIORITIZATION OF PROJECTS:**

The District has a number of projects in the pre-design and design phase. This list consist of projects previously noted as part of the original 42 bond projects and new projects that have been evaluated and prioritized for funding. The projects are as follows:
