### **SUMMARY**:

### CONTINUED FROM THE PREVIOUS PAGE

Since that time, staff has determined that it would be more efficient and cost effective for the District to procure these items directly. To accomplish this, additional services are needed from Dovetail. This amendment confirms current project assumptions and includes additional services to prepare documentation in bidding format, develop scope of work for turnkey services for Owner Furnished Owner Installed (OFOI) items, facilitate bidding process through District Procurement, and manage implementation of OFOI items to completion.

The Board is asked to approve a contract amendment to Dovetail in the amount of \$47,600, bringing the total contract amount to \$157,400.

### **AMENDMENT TO AGREEMENT**

#### PARTIES

This First Amendment to Agreement ("Amendment") is entered into between Solano Community College District ("District") and Dovetail ("Consultant"), collectively the "Parties").

#### RECITALS

WHEREAS, District and Consultant entered into a Consulting Services Agreement ("Agreement"), dated March 18, 2015 for services related to Furniture, Fixtures and Equipment, and (FF&E) for the Biotechnology & Science Building;

WHEREAS, District and Consultant desire to amend the Agreement to confirm current project assumptions and include additional services to prepare documentation in bidding format, develop scope of work for turnkey services for OFOI items, facilitate bidding process through District Procurement, and manage implementation of OFOI items to completion;

NOW THEREFORE, in consideration of the mutual promises and covenants set forth above and contained herein, District and Consultant agree as follows:

#### AGREEMENT

- Section 4 of the Agreement is amended to read: Compensation: District agrees to pay the Consultant for services satisfactorily rendered pursuant to this Agreement a total fee not to exceed One Hundred Fifty Seven Thousand Four Hundred Dollars (\$157,400.00). This fee is a total of March 18, 2015 Agreement in the amount of \$109,800, and Amendment #1 in the amount of \$47,600. District shall pay consultant according to the following terms and conditions:
- 2. The following language is added to Exhibit A:

Add: Revised Project Assumptions:

- (4) user group, (2) key contacts (Dean level or higher)
- (1) new building delivered through the Design/Build process.
- Project schedule will begin March 2015, and Dovetail's scope will complete by October 2017.
- FF&E targeted budget of \$2.7M
- Dovetail scope addresses Group II items only, excluding consumables and supplies, as defined by CCCCO. (*NOTE: All Classroom and Lab AV not provided by DBE, and all IT products, are to be specified, procured and implemented by District IT team. Dovetail will provide space need information for this purpose).*
- A portion of the anticipated FF&E is currently being used in the project swing space, and will need to be integrated by Dovetail into the new building.
- The procurement and coordination of all OF/OI and OF/CI FF&E
- Phase II implementation services (see below) will be performed by the District (see new Phase I and II scope notes below).
- The procurement and coordination of all identified Group II CF/CI items will be performed by the DBE. Dovetail will provide building interface and product specification information for this purpose.
- Project FF&E applications include: (4) Biotech Labs; (2) Anatomy Labs; (2) Biology Labs; (2) Chemistry Labs; (19) Lab Prep & Support rooms including Gowning; (10) Offices; (2) Clean Rooms; (2) Classrooms; (1) Conference Room; (1) Break room; (1) Large Biotech Storage Room; (1)

Darkroom; (1) Copy/Mail Room; (3) Interior Student Spaces; (2) Exterior Student Spaces, and (1) Café.

- All furniture selections will be based on the District Standards.
- Move management services are not included in this proposal.

To the Phase 1 – Planning section:

• Prepare all documentation in bidding format to support District Procurement process. Develop complete scope of work for vendors to facilitate OFOI requirements for Science Equipment and AV requirements only. Develop complete scope of work to provide Turkey Services for Non-Science Equipment and Fixtures products as OFCI installed items.

To the Phase 2 – Implementation section:

- Facilitate bidding process through District Procurement of all FF&E items. Manage implementation of OFOI items to completion.
- 3. Except as set forth in this Amendment, all provisions of the Agreement and any previous extension(s) and/or amendment(s) thereto shall remain unchanged, in full force and effect, and are reaffirmed. This Amendment shall control over any inconsistencies between it and the Agreement and/or any previous extension(s) and/or amendment(s).
- 4. Consultant acknowledges and agrees that this Amendment shall not be binding on the Parties until and unless the Solano Community College District's Governing Board approves this Amendment.
