**NOTICE IS HEREBY GIVEN** that Solano Community College District of Solano County, California, hereinafter referred to as the District, has determined that all prime bidders on the Library/Learning Resource Center Project (Building 100 Replacement) must be pre-qualified prior to submitting a bid on that project. It is mandatory that all Contractors who intend to submit a bid, attend the Mandatory Pre-Submittal Conference, fully complete the Request for Prequalification Questionnaire, provide all materials requested therein, and be approved by the District to be on the Qualified Bidders List. **When the project is issued for bid, no bid will be accepted from a Contractor that has failed to comply with these requirements. Fully completed Request for Prequalification Questionnaires must be received by the District no later than June 25, 2019 at 2:00 P.M.**

The Library/Learning Resource Center Project, located at 4000 Suisun Valley Road, Fairfield, CA consists of construction of a 59,000sf two story building, demolition of the old library and some portable buildings, and site improvements. The anticipated cost of the project is approximately \$34 million.

Contractors are required to submit a Pre-qualifications Package to include one (1) unbound hard copy, five (5) bound copies and one (1) electronic copy (disk or flash drive, Word or PDF format) in a sealed envelope or box identified as **"RFQ #19-009 PREQUALIFICATION FOR GENERAL CONTRACTORS FOR THE LIBRARY/LEARNING RESOURCE CENTER PROJECT (BUILDING 100 REPLACEMENT)"**, with the Respondent's firm name and address clearly indicated.
