Question: The general conditions call for pollution liability and a 3 year warranty but the special conditions remove the pollution liability. The addenda call for hazardous materials and for contractors to have the proper certifications. Does this mean pollution liability is reinstated as a requirement? Or, is this referring to contractors having lead/RRP certifications?

Response: The insurance requirements in the Special Condition have been updated to match the insurance requirements shown in the General Conditions, see item 1.1 above. See Specification Section 00 72 13, subsection 14 and Specification Section 01 78 36 for warranty information. Warranty Period will be for one (1) year as noted in the Contract Documents.
