1. **Announcements**: Lt. Travis welcomed members. Meeting started at 0905 hours.

2. **Current Events/Concerns:**

- a) Lt. Travis provided the committee with an update on the current public safety status of our college campuses. There was nothing serious to report or anything to be concerned about. The Campus Sheriff's Office had taken a few minor theft and one property damage only vehicle collision reports throughout the month of April and early May.
- b) Lt. Travis updated the committee on the May 24, 2018 graduation ceremony planning. He said Rischa Slade was coordinating with those involved to finalize the planning for the event. He believed it will be another successful graduation event for this year.
- c) Lt. Travis stated Jim Petromilli is still waiting for the Apple Store to approve our application for a Solano SAFE app account. Apparently the Apple Store is taking their time on approving our request because it has been over a month now since Jim Petromilli submitted our application. However, as soon as the Apple Store approves our application, we should be able to roll out the app pretty quickly. The Safety Committee will assist in coming up with ways to promote/market the app to our students, faculty, and staff.
- d) Robert Diamond informed the group that the Board of Trustees had approved \$50,000 for the Safety Committee to purchase emergency radios and also three radio towers. We will need to purchase this equipment before this fiscal year ends, otherwise we will have to go back to the Board to request the money again next fiscal year.
