

Technical Review Committee

Approved Minutes February 6, 2018 Meeting Room: 743 1:30 pm – 3:30 pm

1. Call to order

Chair Jim DeKloe called the meeting to order at 1:37pm.

2. Roll Call

Jim DeKloe (Chairperson), Lisa Abbott (Analyst), Curtiss Brown (Articulation Officer), David Williams (VP of Academic Affairs), and Jose Cortes.

Absent: Dean Morinec, Amy Obegi, and Deb Berrett.

Guest: Ferdinanda Florence.

3. Agenda Approval

Jose Cortes motioned to approve the agenda of February 6, 2018 and add item GE - CDFS 053 Option C on the agenda. It was seconded by Curtiss Brown. The motion passed since two thirds of the vote was obtained.

4. Approval of Minutes

There were only two minutes on the agenda. The minutes of November 21, 2017 was not completed and not included in the meeting packet. Jose Cortes motioned to approve the minutes of January 23, 2018 and November 7, 2017. It was seconded by Curtiss Brown.

5. Comments from the Public

There were no comments from the public.

6. Action Item6.1 Deletion of CDFS 053Under Option C – Curtiss

Brown.

Articulation Officer Curtiss Brown stated that CDFS 053 is not part of the Option C CSU General Education/SCC graduation requirement. Therefore, to be consistent with both options, it is recommended that CDFS 053 be removed; otherwise students will need to take an additional course in order to receive an A.A. in IGETC option B. He had convened with faculty from this department and agreed to remove CDFS 053 from IGETC B with goal of modifying it to satisfy cross-cultural family and to design it to be UC transferable.

7. Consent Items for Curriculum Committee 7a. Inactivation of THEA 048A. This had not been submitted for full Chancellor's Office approval. The department missed the opportunity to submit a complete proposal, as a result this course will not be included on the next SCC catalog. Curtiss Brown motioned to approve inactivation of THEA 048A and will be forwarded to Curriculum Committee for further review. It was seconded by Jose Cortes. The motion passed unanimously.

8. New Course

8a. (CP18S-21) EDUC 001 Elementary Teacher Education

1. Action on the Course:

Maureen Powers authored this course. Amy Obegi also contributed to this course. There was a concern regarding the course CID. Also, this class will be included on the upcoming A.A.-T. Ferdinanda Florence clarified that this will be a two-unit class and to include K-12 on the course description. Jose Cortes motioned to approve this course. It was seconded by Curtiss Brown. The motion passed unanimously.

9. Course Modification

<u>9a. (CP18S-2) KINE 004E Dance Production: Description, Repeatability, Assignments, Content, Textbooks, Hours</u>

1. Action on the Course:

The department changed the units and hours for this course. The hours were modified to accommodate production hours. Jose Cortes motioned to approve KINE 004E. It was seconded by Curtiss Brown. The motion passed unanimously.

9b. (CP18S-17) ART 044A Art Studio Concepts: Number (075-044A), Transferability, Articulation Information, Textbooks

1. Action on the Course:

Lisa Abbott stated that this course missed the opportunity to include information on division planning and SLOs on META. The units were modified from 3.5 to 3 units due to ADT policy. The committee had inquiry regarding the class variable units. After discussing the course variable units with Ferdinanda Florence, three units will be assigned for this course. Ferdinanda Florence requested to "unlaunch" the class. Jose Cortes motioned to approve this course. It was seconded by Curtiss Brown. The motion passed unanimously.

9c. (CP18S-19) BUS 097 Work Readiness: Number (100-097), Description, Transferability, Articulation Info, Content, Textbooks

1. Action on the Course:

Curtiss Brown stated that this course was similar to Counseling 005. Chair DeKloe stated that student success information was not completed. Jose Cortes motioned to table BUS 097 to the department due to incomplete SLO on META and required clarification on articulation, minimum qualifications, and division planning. It was seconded by Curtiss Brown. The motion passed unanimously.
