1. Call to order

3. Agenda Approval

Dean Morinec motioned to approve the agenda as presented. It was seconded by Deb Berrett. The motion passed unanimously.

8. New Course

## 8a. (CP18S-73) ART 044 Introduction to Digital Design and Computer Technology

1. Action on the Course:

Rachel Smith, the author of this course, addressed the committee's inquiries regarding the following: (1) incongruent number of units and hours (2) course prefix change needed for 8a, 8b, and 8c, (3) whether these courses should be assigned variable units, (4) recommended to submit a course modification, and (5) whether it will be a TMC or certificate. With the author's permission, the minimum qualification was modified to Art, Graphic Arts, or Commercial Art, a course objective was added, and modified to 2 hours of lecture and 4 hours of lab to equal 3 units. Deb Berrett motioned to approve ART 044. The motion was seconded by Jose Cortes. The motion was carried.

# 8b. (CP18S-74) ART 044A Design Bootcamp

- 1. Action on the Requisite: None
- 2. Action on the Course:

The committee recommended to change the course number from 044A to 144A. With the author's permission, verbiage on the Course Description was modified. The author agreed to remove the DE aspect from this course. The course prefix needed to be modified. Deb Berrett motioned to approve this course. It was seconded by Jose Cortes. The motion passed unanimously.

#### 8c. (CP18S-75) ART 047C Introduction to 3D Animation

#### 1. Action on the Course:

With the author's permission, the committee made changes on minimum qualifications, Top Code was updated to 101300, modified the repeatability language, and completed information on Course Objectives. The course prefix needed to be updated. In order to keep the course number, the committee recommended that the author provide articulations information. Deb Berrett motioned to approve this course. It was seconded by Jose Cortes. The motion passed.

1. Action on the Program:

Ferdinanda Florence convened with Dean Connor and Nick Cittadino regarding redesigning this degree to model Sonoma State's bachelor's degree in Liberal Arts. Only 53% of the courses will articulate to Sonoma State. The committee recommended to invite Nick Cittadino and Dean Connor at the next Curriculum Committee meeting, that the department provide articulation agreement for this program, and to possibly eliminate courses from the list. Deb Berrett motioned to approve 13b and to forward this program to the Curriculum Committee to discuss its philosophical aspect. The motion was seconded by Jose Cortes. Roll call vote: Deb Berrett, Jose Cortes, and Curtis Brown votes for the motion. Dean Morinec voted against the motion. The motion passed with majority of the vote.

# 13c. (CP18S-122) Mechatronics Certificate of Achievement: Courses 13d. (CP18S-123) Mechatronics A.S.: Courses

1. Action on the Programs:

Douglas Green stated that the new name will reflect the degree/certificate. There was an overlap between IT 050 and IT 101; therefore, the department decided to assign IT 050 as an elective course. Also, IT 174 was added as an elective. With these changes, the unit value was modified from 42 units to 39-40 units. With the author's permission, the committee modified the language on the Course Description on META and removed IT 110 from the elective list. Deb Berrett motioned to combine items 13c and 13d and to approve these modifications. It was seconded by Dean Morinec. The motion passed unanimously.
