1. Call to Order	Technical Review Committee Chair Jim DeKloe called the meeting to order at 1:33 pm. This meeting was held via Zoom due to SARS-CoV-2 pandemic.
2. Roll Call	Jim DeKloe (Chairperson), Lisa Abbott (Analyst), Curtiss Brown (Articulation Officer), David Williams (VP of Academic Affairs), Andrew Wesley (Assessment Coordinator), Sandy Lamba (Dean), Deb Berrett (Faculty), and Mark Berrett (Faculty) Guests: Michael Goodwin, Teri Yumae, and Melanie Lutz.
3. Agenda Approval	Mark Berrett motioned to approve the agenda of April 14, 2020 as presented. It was seconded by Deb Berrett. 8. New Course	<u>8a. ATHL 005 Men’s Intercollegiate Soccer (Fall)</u> Curtiss Brown explained that the Athletics department would like this course reviewed/approved in the event that in-person classes would be allowed in the near future. He also clarified that this will not be included on the next academic year catalog due to process/timeline involved with ASSIST/GE approval. <ol style="list-style-type: none">1. Action on the Course: Deb Berrett motioned to approve ATHL 005. It was seconded by Dean Sandy Lamba. This new course was approved unanimously. <u>8b. CJ 080 The Criminal Justice System Viewed Through a Multi-Cultural Lens</u> The committee reviewed the following: (a) whether this course will be “occupational,” (b) using the word “gender” instead “genders,” course objectives, and SLOs. The committee recommended to add another course objective for CSU qualification reason. <ol style="list-style-type: none">1. Action on the Course: Mark Berrett motioned to approve CJ 080. It was seconded by Deb Berrett. This new course was approved unanimously.

8c. CJ 082 Victimology: Victims and The Criminal Justice System

The committee reviewed this course local requirements, course outline, and Option A. Chair Jim DeKloe will contact the department to request adding another course objective and expand acronyms.

1. Action on the Course: Curtiss Brown motioned to approve CJ 082. It was seconded by Mark Berrett. This new course was approved unanimously.

8d. CS 104 Programming in Linux

Mark Berrett explained that this course is created to modernize Computer Science by utilizing Linux. This will be a half-unit laboratory, will be taught online, occupational, no prerequisites, and students will be using Java. He stated that he created this course and is not offered at other colleges at this time. This will be program applicable. Lastly, Mark Berrett explained that submission of completed assignments (computer code) will be forwarded to the instructor (SLO).

1. Action on the Course: Deb Berrett motioned to approve CS 104. It was seconded by Curtiss Brown. This new course was approved unanimously.

8e. CS 105 Programming in Windows

After further review, the course minimum qualifications and SLOs were updated.

1. Action on the Course: Deb Berrett motioned to approve CS 105. It was seconded by Curtiss Brown. This new course was approved unanimously.

8f. CS 130 Java 1: Fundamentals

Mark Berrett explained that this will be an introductory (Syntax) course where students will learn how to operate Java, which could take up to 80 hours.

1. Action on the Course: Deb Berrett motioned to approve CS 130. It was seconded by Curtiss Brown. This new course was approved unanimously.

8g. CS 132 Java 2: Program Design and Data Structures

Mark Berrett stated that this course will focus on data analysis. He explained the reason behind the course name (minimize student confusion).

1. Action on the Course: Mark Berrett motioned to approve CS 132. It was seconded by Dean Sandy Lamba. This new course was approved unanimously.

8h. CS 134 Java 3: Project Management

Mark Berrett explained that students enrolled in this course will be working in groups. This will involve coding maintenance, release sets, and project designs.

1. Action on the Course: Deb Berrett motioned to approve CS 134. It was seconded by Dean Sandy Lamba. This new course was approved unanimously.

8i. ENGR 014 Introduction to Statistical Programming in R for Scientists and Engineers

The committee had detailed discussions regarding this new course (i.e. electives for Engineers/certificate, minimum qualifications (Math/Engineering/Computer Science), who could teach this course (cross-listed, Master's degree in Computer Science), and colleges that offer similar course. Mark Berrett motioned to table discussion of this course until the next Technical Review committee meeting where more information and clarifications could be provided by Melanie Lutz/department and will be included on the next TR agenda. It was seconded by Dean Sandy Lamba. The motion was approved unanimously.

1. Action on the Course: None.

Teri Yumae requested to add MUS 005 (Music Fundamentals), which will be required for transferability reason.
