Kathleen Callison shared the reasons why these courses are created. These courses will not be transferrable and a program has not been created. The committee discussed these courses C-IDs.

#### 8r. FOR 070 Forensic Crime Scene Investigation – Basic

#### 8s. FOR 071 Forensic Crime Scene Investigation - Advanced

Ed Goldberg provided information/history of what motivated him to create FOR 070 and FOR 071. Brianne Breedlove, a Forensic Scientist, stated that there are only two Forensic programs, which are both located in Southern California. As a result, Northern California laboratory companies are recruiting in Southern California. Also, she estimated that there are only four universities that offer Forensic Chemistry degree. At this time, these are elective courses with potential to be part of a new program in the near future. Articulation Office Curtiss Brown voiced his concerns/inquiries regarding these courses transferability to CSU, books, C-ID articulation, and prerequisites.

1. Action on the Course: Curtiss Brown motioned to combine and approve items 8r and 8s. It was seconded by Deb Berrett. The motion was approved unanimously.

#### 9a. ASTR 020 Astronomy Laboratory:

When reviewing this course, the committee discussed their concerns regarding transferability and IGETC pertaining to laboratory under Physical/Biological Science, which will be reviewed during the next Curriculum Committee meeting.

1. Action on the Course: Mark Berrett motioned to approve this course. It was seconded by Curtiss Brown. The motion was approved unanimously.

#### 9b. BUS 092 Business Communication

Mark Berrett explained that this course was modified in compliance C-ID. Andrew Wesley reviewed and approved this course's SLOs. Curtiss Brown recommended a lower division course for articulation reason and inquired about GE.

 Action on the Course: Curtiss Brown motioned to approve this course with conditions that the department address minimum qualifications, find a comparable course, and GE. It was seconded by Dean Sandy Lamba. The course was approved unanimously.
