
OEI Consortium To Expand, Focus On Equity

Since the inception of the Online Education Initiative (OEI), many California community colleges have collaborated to increase student access to fully resourced online courses that address achievement gaps and propel them toward completion.

During this time, our system has seen the average gap between face-toface and online success rates narrow to less than 6 percent, and our data shows OEI pilot courses moving 4.9 percent above the statewide average.

There are many components now deployed within and beyond the 24-college OEI Consortium that are benefitting students and colleges in our system — Canvas, online tutoring and counseling platforms, online student readiness resources, professional development and more — with the Course Exchange continuing its rollout as the most technically complex component. The OEI always planned to expand the consortium to include more colleges in the good work we are doing alongside our member colleges.
