6.2 Update From Area B Meeting of March 22, 2019

AS President Jaimez provided the Senators the following updates: ASCCC will be partnering with ACCJC in accreditation institutes. Going forward they will alternate hosting this training. The VP of ASCCC reported that there is more transparency and effective participation with the Chancellor. ASCCC has made three recommendations regarding the funding formula, level points for all associate degrees, only account one award per student per year, and keep performance metric at 10%.

7. Superintendent-President Report

S/P Celia Esposito-Noy provided faculty hiring updates: (a) full-time ASL faculty will be on the April 3, 2019 board agenda, (b) second level interview for History position in process, (c) second level interview for Anatomy faculty scheduled for April 2, 2019, and (d) Accounting faculty interview in progress. The second interviews included deans and faculty co-chairs. Secondly, she informed the Senate that the department of Finance created Student Center Funding formula advisory committee. She will share the results of the committee meeting with AS President Jaimez. Lastly, S/P Celia Esposito-Noy explained the reasons why Emeritus benefits are limited: (a) free theatre season pass will not be possible due to cost involved in theatre productions and will be not within the realm of administration to approve; this will also apply with athletics conferences/competitions, (b) parking permit will be free, possibility of creating email address, and identification card, (d) a certificate will be provided by Academic Affairs, (e) the possibility of inviting Emeritus winner to attend SCC graduations and Convocations, (f) office space will not be included, and (g) Emeritus status is separate from the naming rights of SCC board policies.

11.1 Local GE Modification Requirements (Option A) – James DeKloe There were no items on this section.

Jim DeKloe, Curriculum and Tech Review Committee Coordinator, provided the Senate information regarding, "Local General Education Modification Requirements (Option A)," (see attached document). The Senators had the following discussions: (a) this proposal originated from CTE department and presented by Deb Berrett, (b) Soft Skills should be mandatory on GE, (c) the Senate office will confirm if this was outlined in the Curriculum handbook and if not, a process will need to be developed (d) the need to generate impact report and definitions of lower and upper division for clarification reasons, and (e) AS President Jaimez and Jim DeKloe will discuss this in details and will be presented to Senate to finalize future plans.

11.2 Professional
Development /Flex Test and
Flex Lists – LaNae Jaimez

AS President Jaimez presented, "PD/Flex Test," (see attached document). She informed the Senators that PD committee is creating standardized list of preapproved and flex and funding eligible activities. After reviewing the handout, Senators provided input, which will be forwarded to Michelle Smith, PD/Flex Cal Coordinator, for review and consideration.

11.3 Guided Pathway Update – Michael Wyly

Michael Wyly, Guided Pathway Coordinator, presented, "GP Essential Practices Scale of Adoption Self-Assessment," (see attached document). He stated that the first stage will be completed and submitted to the Chancellor's office no later than April 20, 2019 with the intention of informing Professional Development opportunities next calendar year. The second stage will occur on September 2019, which will require signatures from Academic SCC Senate President Jaimez and Superintendent/President Esposito-Noy and will be presented back to Senators for formal discussions/review. While reviewing the document provided, Senators had inquiries regarding: (a) utilization of PACE instead of META-Major, (b) MATH 011 and 012, (c) Community Colleges usage of MyPath, (d) the need of feedback on the scale and soliciting scale of adoption, and (e) clarifications on items 3e, 4b, 4c, and 4d. Michael Wyly requested Senators to review the document and to provide him feedback via email.

11.4 AP/BP 6200 Graduation Requirements for Degree and Certificates VP Williams presented AP/BP 6200 to Senators. He stated that this updated version of the document included unit value modification. There was a detailed discussion regarding, "Ethnic studies must be
