The bill in question would require that a community college district or community college not recommend or require students to enroll in pre-transfer level English or mathematics coursework except under specified circumstances.

7. Superintendent-President Report

Celia Esposito-Noy

Several 4-year schools and other community colleges have dropped the indoor mask requirement. However, these are schools that have a vaccine/booster mandate. Currently, the mask mandate at Solano will stay in effect through the spring semester.

The college is joining the USC California Community College Racial Equity Leadership Alliance. This resource will give us access to their portals, workshops, etc. T4E leaders will be asked to be part of the team to attend the April sessions.

Dr. Brian Bedford gave the first of 3 presentations last Friday. In these presentations, Dr. Bedford will share his research on the disproportionate underrepresentation of Black men in educational and executive leadership positions and facilitate dialogue about our notions of equity and opportunity in the workplace. Approximately 15 people attended the first session. Dates for the additional two sessions will be scheduled soon.

There were 2 very qualified candidates for the Anatomy/Physiology faculty position. Therefore, the Academic Senate was informed that both candidates will be offered a position. This was an opportunity that could not be passed up, but it will not affect the other positions that are currently going through the hiring process. S/P Esposito-Noy will provide a written response regarding the change to the hiring prioritization as is required by our process.

11.1 Resolution 03.28.2022: Application for Solano College to Become a California Virtual Campus - Online Education Initiative Consortium Member

Senator Purdie motioned to approve item 11.1; Senator Sytsma seconded the motion; motion carried with 10 ayes, 1 nay, and 2 abstentions.

This resolution is the first official step for Solano College to become a California Virtual Campus. It was presented to the DE Committee on March 4th and received a unanimous "yes" vote. Benefits include outreach and marketing. Concerns that were raised included a lack of local control and how the load in courses might be handled. Another concern/question was Solano's acceptance of courses taken at other colleges. It was clarified that not every class at Solano would be part of this initiative. Also, there are rules in place for student workload. Processes and policies would need to be put in place for all aspects of this resolution. Currently, students can already take courses on the exchange. In addition, it was clarified that students can already take online classes at any college in California. The exchange makes the process easier for students because they can do this without applying to the college, dealing with financial aid issues, etc. In addition, it allows students to seamlessly take rigorous online courses. The vote is to confirm if Solano should offer courses on the exchange.

12. Information/Discussion Items

12.1 RSSC Campus Climate Survey

Attendees from RSSC included Dr. Regina Stanback Stroud (CEO), Brandon Christian (Director of Communications and Operations), Dr. Sheila Smith McKoy (Consultant), and Dr. Aaron McVean (Consultant). RSSC has been asked to work with Solano College on a campus climate survey with a specific emphasis on racial and cultural climate. Previously conducted student focus groups revealed extensive comments related to students' racial experiences. The recommendation that resulted from these focus group is this campus climate survey. RSSC explained the value of such a survey as well as considerations for the type of survey that might be considered. The suggested timeline is 4 weeks for evaluation and survey selection followed by 5 weeks of an awareness campaign. Administration of the survey would take place in fall, 2022. Comments from the Academic Senate included a preference to capture feedback from as many students as possible and a suggestion to implement the campaign in the fall followed by the survey. RSSC would like to know what is most important to the Academic Senate so that they can move forward with recommendations that will meet the needs and requirements of Solano College. RSSC is reaching out and meeting with different groups at Solano, including SESC and ASSC. Moving forward, the recommendation from the Academic Senate is to have RSSC work closely with SESC.

12.2 Taskforce Update: Return to Campus

Academic Senate VP Scott shared data as well as a summary of student panel comments from the March Flex day. Some data highlights are the reduction of headcount over the past years. The demographics by race remained steady. The data also showed an overall increase in CWs and EWs starting spring, 2020. Overall, the following groups experienced a disproportionate negative impact during the pandemic: African American students, DSP students, EOPS students, students with low high school GPA, and 18-24 year olds. The Academic Senate was asked to start thinking about things that can be done to support students moving forward. AS President Jaimez requested specific recommendations from the taskforce. In addition, it was mentioned that it's difficult to move forward with recommendations when the reasons for the data results are not always clear, meaning we may need to do follow up work (focus groups, surveys, etc) in order to understand why these particular groups struggled and what is needed going forward. In the interest of time, this presentation and discussion will continue at a future Academic Senate meeting.
