1. Call to Order/Land Acknowledgement

Senator Barsness read the land acknowledgement: "We should take a moment to acknowledge the land on which we are gathered. For thousands of years, this land has been the home of PUTT-win people. Today, there are three federally recognized Patwin tribes: CATCH - ill DEE - HEE Band of WIN - tune Indians of the Colusa Indian Community, KLET-SELL DEE-HEE Band of Wintun Indians, and YO-chuh DEE-HEE Wintun Nation.

The Patwin people have remained committed to the stewardship of this land over many centuries. It has been cherished and protected, as elders have instructed the young through generations. We are honored and grateful to be here today on their traditional lands."

7. Superintendent-President Report

- Celia Esposito-Noy (10 minutes): Mask and Vaccine mandate on the agenda. Spoke with ASSC, Local 39, CSEA, faculty – got feedback from all. The faculty union has stated its support for a vaccine mandate. If passed, looking at ways to implement this in ways that are fair and manageable and that respect individual privacy concerns. The effects of a vaccine mandate are negotiable; will speak with bargaining units' leadership. Great student input. No student should be unable to complete a program if they are unable to come to campus. If passed, implement no earlier than October 15. Will provide testing on campus. In some professions, vaccinations will be required so this would prepare them for their professional lives. Support voiced for following the science and including an education component. Will establish another vaccine clinic on campus. Discussing incentives to everyone who gets or is vaccinated via CARES money. Pursuing 3rd party vendors to assist with implementation (may get some help from Touro U). Compliance with the mask mandate has been good. Let Pres. Jaimez know if you want to participate in the COVID workgroup that meets on Sept 23.

- S-P DEI: Conversations ongoing; Celia is meeting with an LGBTQ representative to incorporate this into diversity efforts.
