1	Integrate Solano Courses with the CVC	IP	As of January 1, 2023, SCC is now a Home College as defined by the California Virtual College Next steps will be preparing the college for Teaching College status. This process will be more in-depth and require partnership with many different departments on campus.
2	Develop a long-term Distance Education support team	IP	The committee has worked with an external consultant to create an onboarding program for new faculty. At the end of the contract, this new program was not appropriate for new hire training but will be considered for faculty refresher courses. Interim solution is to adopt @One basic and accessibility training for new online certification. Future steps will be ongoing program development for online instruction and refresher courses to address changes in state and federal laws. Develop job description and hire Director, Distance Education with a hire goal by FA23.
3	Support ongoing training for online certification for new faculty	IP	Currently using the 3/3/22 MOU to guide training and online certification for new faculty. In partnership with our union, administration, and committee, working to develop standards for ongoing training and recertification for online instruction.
4	Develop high quality review process for online courses.	IP	Phase II of the CVC integration involves a detailed program for certifying courses for the exchange. This semester the DE Committee will finalize a POCR (Peer Online Course Review) process for adoption by the senate and the college. This program is essential for quality online courses listed in the CVC.
