Hello all.

On Monday we'll be discussing ChatGPT, its impact on our school/classrooms, and what role the Senate might have as the campus wrestles with this new technology. In preparation, I wanted to share with you some resources.

First, if you haven't already done so, I recommend you play around a little with <u>ChatGPT</u>, including giving it any prompts/questions you provide students. I asked it to compare/contrast two poems we're discussing in my class, and it did write a coherent (but not inspiring) essay in response in less than two minutes. It also has quite a few opinions as to how best we can utilize ChatGPT at Solano College (see below).

The Chronicle of Higher Education also recently hosted <u>a roundtable</u>, where faculty discussed "the potential and pitfalls of an Al-enabled academic future." It's interesting and worth a listen if you have an hour.

Some have catastrophized this future (<u>this op-ed</u> compares this moment to the beginning of the COVID pandemic), others blame academia (like <u>this letter to the editor</u>), while still <u>others</u> believe ChatGPT offers us the opportunity to put the nail in the coffin of a system and way of instruction that does not benefit or honor our students or the learning process).

For our meeting, I want us to focus on three questions:

- 1. How do we see ChatGPT impacting our college now, and how do we predict it might impact the teaching and learning experience over the next 5 years? (we will be sure to save these notes for our future colleagues to enjoy over cyber-beer and tea)
- 2. What do we believe is the most student- and learning-centered response? How should we engage AI in our classrooms?
- 3. Is there a further role for the Academic Senate in this conversation? Should we advocate for policies, resources, or professional development?

I'm looking forward to the conversation. Below is a transcript of a short (4 minute) conversation I had with ChatGPT as I was preparing for this meeting.
