A/S PRESIDENT'S UPDATE

- Fall Plenary will be a hyflex event, November 3-5 in Sacramento
- SESC Status: The chair position is a priority that needs to be filled; Administration is evaluating the release time.
- Health Sciences has one vacant senator position still open; Robin Sytsma is sitting in for now.
- ASSC Senate and Elections Promotion: please share the <u>election information</u> with your students
- Vacant PDFC Position: a part-time faculty representative position is open
- Vacant Program Review Committee Position: a Health Sciences representative position is open

S/P ESPOSITO-NOY REPORT

Housing update: The Scion group presented at the last Board meeting; there is funding for housing through the CC system. A survey of over 700 students showed interest in mixed generation housing. Seniors and retired faculty plus students would create a residential education/community. An advisory committee for this project is open to any who would like to participate.

Football was also discussed at the recent Board meeting. Costs to bring Football back would be \$500K per year plus the cost of renovating facilities. A study session is coming on this topic.

VPAA REPORT - David Williams

We are now in the <u>CVC/California Virtual College</u> consortium, effective immediately. Eventually, once the technical details are completed, our students will be able to take classes at other colleges in the system without having to enroll in those colleges; similarly, students from other colleges in the consortium can enroll in classes with us.

Flor de Maria Cruz is the new Vacaville Center Supervisor. Services and resources at both Centers are in process to make sure students have what they need.

VPSS REPORT – Lisa Neeley

- Student Services are open, in person on the FF campus this Fall: TWTh 10am-4pm
- TimelyCare online counseling and support roll out continues; a consultation line for faculty/staff is available there as well.
- Workshop series focusing on mental health for faculty/staff is in the works.
- Student Wellness Center is opening 12:30 on 8/31 (1400 bldg). This will be a referral and hangout space, not a clinical site.

Dreamer Resource Liaison - Cristina Sanchez

Cristina presented about the undocumented student experience and her liaison role (AB 1645 requires each CA higher education campus to provide a liaison role like this). Preliminary SEA (Student Equity & Achievement) Plan Update – Lisa Neeley, Melissa Reeve, and Shirley Lewis

A new plan is in the works (our 2018-2022 plan is sunsetting). We are looking to integrate areas beyond student services in the new plan, which is due November 30. The new plan will need to shift to be race-conscious.

Melissa presented a snapshot of data on our five metrics (below). This snapshot is where we are at with our current 2018-22 plan (two years worth of results):

- Enrolled in the same Community College not met
- Transfer level Math and English in first year yes, exceeded
- Retention/Persistence- not met
- Transfer- not met
- Completion (degree/certificate) yes, exceeded

The areas that reflect "not met" are largely impacted by the pandemic; the Chancellor's office knows this. Senate discussed some of these data points and anomalies between the data and what some are seeing in their classrooms. This may be the result of students' lack of willingness to self-report, especially in stigmatized categories such as homelessness.

Polls will be sent out so we can identify/determine desired granular levels of analysis for our

metrics in tandem with race, and more.

Follow-Up: 2 part Hiring Prioritization Process – Josh Scott

Presented revised draft and discussed various aspects of the proposal and process, how advisory boards affect areas under CTE in regards to hiring, an accelerated timeline, etc.

S/P Esposito-Noy and VPAA Williams will bring this revised proposal to the Deans for continued discussion.
